REGULATION OF THE COUNCIL OF MINISTERS

of 24 December 2007

on the Polish Classification of Activities (PKD)

(Journal of Laws of 31 December 2007)

Pursuant to Art. 40 section 2 of the Law of 29 June 1995 on Official Statistics (Journal of Laws No. 88, item 439, as amended¹⁾) the following is hereby ordained:

practical notes

- § 1. The Polish Classification of Activities (PKD), hereinafter referred to as "PKD 2007" and comprising an appendix to this Regulation, shall be introduced to be used in statistics, registration, documentation and accounting, and also in official registers and public administration information systems.
- § 2. Starting from the coming into force of this Regulation, entries in the Business Activity Register kept by the National Court Register and in the National Register of Taxpayers shall be made in line with PKD 2007.
- § 3. ⁽¹⁾ 1. Entities entered in the National Official Business Register REGON, hereinafter referred to as the "REGON register", shall be successively reclassified in accordance with PKD 2007 by 31 December 2009 pursuant to § 14 section 1 point 6 of the Regulation of the Council of Minister of 27 July 1999 on the procedure and methodology of keeping and updating the register of entities of the national economy, including the templates of applications, questionnaires and certificates, and also on the special conditions and procedure of cooperation between the services of official statistics and other bodies keeping official registers and public administration information systems (Journal of Laws No. 69, item 763, of 2001 No. 12, item 99, of 2003 No. 221, item 2195, and of 2008 No. 168, item 1041), hereinafter referred to as the "Regulation", subject to sections 2 and 3.
- 2. Should it be impossible to conduct the reclassification of activities of entities entered in the REGON register in accordance with PKD 2007 and in a way stipulated in section 1, the reclassification is to take place pursuant to § 14 section 1 point 4 of the Regulation.
- 3. The activities of entities entered in the REGON register which will not reclassified by 30 September 2009 pursuant to sections 1 and 2, shall be reclassified *ex officio* by the services of official statistics.
- 4. Certificates on the REGON identification number shall be issued to the entities referred to in section 1 following the update of the REGON register, pursuant to sections 1-3, in a manner stipulated in § 14 section 5 of the Regulation.

- § 4. The Polish Classification of Activities (PKD) introduced by way of the Regulation of the Council of Ministers of 2 January 2004 on the Polish Classification of Activities (PKD) (Journal of Laws No. 33, item 289 and No. 165, item 1727) shall apply to activities determined in accordance with this classification before the coming into force of this Regulation; however, no longer than until 31 December 2009.
- § 5. The Regulation of the Council of Ministers of 20 January 2004 on the Polish Classification of Activities (PKD) (Journal of Laws No. 33, item 289 and No. 165, item 1727) shall expire.
 - § 6. This Regulation shall become effective on 1 January 2008.
