Foreign trade turnover of goods in total and by countries in January - April 2023

Foreign trade turnover¹ in January - April 2023 in exports at current prices amounted to PLN 550.7 bn, while in imports - PLN 531.4 bn. The positive balance reached the level of PLN 19.2 bn, while in the same period of 2022 year was negative and amounted to PLN 32.6 bn. In comparison to the corresponding period of last year exports increased by 10.2%, while imports decreased by 0.2%.

Foreign trade turnover expressed in US dollars and in EUR

Exports expressed in USD amounted to 125.7 bn, while imports amounted to USD 121.3 bn (an increase in exports of 2.5% and decrease in imports of 7.1%). The positive balance reached the level of USD 4.4 bn, while in the same period of 2022 year was negative and amounted to USD 8.0 bn.

Exports expressed in EUR amounted to 117.0 bn, while imports amounted to EUR 112.9 bn (an increase in exports of 7.3% and decrease in imports of 2.8%). The positive balance reached EUR 4.1 bn, compared to a negative balance of EUR 7.1 bn in the same period of 2022.

Foreign trade turnover of goods in total and by groups of countries

Poland has the largest share in total exports with the developed countries – 86.9% (of which EU 75.3%) and in imports – 65.0% (of which EU 53.3%), in comparison with 88.5% (of which EU 77.0%) and 61.7% (of which EU 52.8%) in the corresponding period of 2022. However, the smallest share was observed with the countries of Central and Eastern Europe, which in total exports amounted to 4.8%, and in imports – 2.9%, in comparison with 3.9% and 9.1% in January - April 2022.

The negative balance was recorded with the developing countries – minus PLN 125.1 bn (minus USD 28.6 bn, minus EUR 26.6 bn). The positive balance was obtained in turnover with other groups of countries, i.e. Central and Eastern Europe PLN 11.1 bn (USD 2.5 bn, EUR 2.4 bn) and with developed countries PLN 133.2 bn (USD 30.4 bn, EUR 28.3 bn), of which with the EU countries the balance of PLN 131.6 bn (USD 30.0 bn, EUR 28.0 bn).

Foreign trade turnover by major countries

In January - April 2023 among the main trade partners of Poland increases in exports were observed compared to January - April 2022. However, in January - April 2023 imports decreased with Italy by 7.0%, Belgium by 5.2%, China by 5.0%, Germany by 4.4% and Czechia by 1.5% in comparison with the same period of 2022.

The turnover with the top ten of Polish trade partners in exports accounted for 66.1% (65.2% in the same period of 2022 year), while in total imports – 60.0% (in comparison with 58.9% in January - April 2022).

The share of Germany in exports decreased in comparison with the corresponding period of 2022 year by 0.1 pp and amounted to 28.2% and in imports decreased by 0.9 pp and accounted for 19.8%. The positive balance amounted to PLN 49.9 bn (USD 11.4 bn, EUR 10.6 bn) in comparison with PLN 31.1 bn (USD 7.6 bn, EUR 6.7 bn) in the same period of 2022.

² Country of origin is the country where the commodity was produced or processed and in this form entered the Polish customs zone.

The highest turnover in imports by country of consignment Poland recorded with the developed countries - PLN 398.9 bn, of which with the EU – PLN 353.6 bn, compared to PLN 376.9 bn, of which with the EU - PLN 345.8 bn in the same period of 2022.

Imports by country of consignment – countries

The share of Germany in imports by country of consignment in comparison with imports by country of origin was higher by 5.4 pp, accordingly the share of the Netherlands was higher by 2.5 pp, Belgium by 1.7 pp, Czechia by 0.9 pp and France by 0.5 pp.

In January - April 2023 trade turnover in goods according to the SITC nomenclature reported an increase in 6 commodity sections in exports and in 4 commodity sections in imports compared to the same period of 2022.

In exports the largest increase concerned animal and vegetable oils, fats and waxes (by 39.4%), beverages and tobacco (by 31.0%), food and live animals (by 21.4%), machinery and transport equipment (by 19.6%), mineral fuels, lubricants and related materials (by 11.9%), miscellaneous manufactured articles (by 7.1%), There was a decrease in commodities and transaction not classified elsewhere in the SITC (by 38.3%), crude materials inedible, except fuels (by 13.2%), manufactured goods classified chiefly by material (by 2.7%) and chemicals and related products (by 1.3%).

In imports an increase was recorded in beverages and tobacco (by 26.0%), mineral fuels, lubricants and related materials (by 20.7%), food and live animals (by 18.8%), machinery and transport equipment (by 10.5%). The largest decrease was recorded in commodities and transaction not classified elsewhere in the SITC (by 58.3%), manufactured goods classified chiefly by material (by 15.2%), animal and vegetable oils, fats and waxes (by 11.4%), crude materials inedible, except fuels (by 7.3%), miscellaneous manufactured articles (by 1.7%) and chemicals and related products (by 1.4%).

Chart 1. Composition of exports by sections according to SITC nomenclature in January - April 2023





Chart 2. Composition of imports by sections according to SITC nomenclature in January - April 2023
