

Residential construction¹ in the period of January -October 2023

95.7 Index number of dwellings completed y/y In the period of January - October 2023, there were less dwellings completed than the year before. The number of dwellings for which permits have been granted or which have been registered with a construction project as well as dwellings in which construction has begun also decreased.

Dwellings completed

According to the preliminary data, 180.9 thousand dwellings were completed in the period of January - October 2023, i.e. 4.3% less than in the corresponding period of 2022. Developers completed 110.4 thousand dwellings – by 2.5% less than a year ago, whereas private investors completed 66.9 thousand dwellings, i.e. by 8.5% less. Within these forms of construction, 98.1% of the total number of newly completed dwellings was built. Within other forms of construction, i.e. cooperative, municipal, public building society and company construction 3.5 thousand dwellings were completed (2.7 thousand in the previous year).

The total useful floor area of dwellings completed amounted to 16.5 million m², i.e. by 6.3% less than a year ago and the average useful floor area of 1 dwelling was 91.0 m².

Dwellings for which permits have been granted or which have been registered with a construction project

In the period of ten months of 2023, permits and registrations have been granted for construction of 198.4 thousand dwellings, i.e. by 23.1% less than in the corresponding period of 2022. Permits for construction of the biggest number of dwellings were given to developers (131.8 thousand, a decrease of 25.0% y/y) and to private investors (60.8 thousand, a decrease of 22.6%). Within these forms of construction, permits have been granted and registrations with a construction project were made for 97.1% of dwellings in total. In other forms of construction 5.8 thousand dwellings for which permits have been granted or which have been registered with a construction project were noted (in the previous year 3.7 thousand). The number of dwellings for which permits have been granted or which have been registered with a construction project decreased in the period of January - October 2023 by 23.1% y/y

Dwellings in which construction has begun

From January to October 2023, the number of dwellings in which construction has begun was 158.6 thousand, i.e. by 11.1% less than a year ago. Developers have started construction of 92.5 thousand dwellings (by 8.4% less), and private investors of 62.3 thousand (by 16.8% less). Altogether the share of these forms of construction was 97.6% of the total number of dwellings. In other forms of construction the number of dwellings in which construction has begun was 3.9 thousand (2.6 thousand in the previous year).

It is estimated that at the end of October 2023, there were 810.9 thousand dwellings under construction, i.e. by 5.8% less than in the corresponding month of 2022.





In the period of January - October 2023, the highest values of dwellings completed, as well as dwellings in which construction has begun and dwellings for which permits have been granted or which have been registered with a construction project, were recorded in Mazowieckie voivodship (respectively: 34.6 thousand, 31.0 thousand and 36.1 thousand dwellings). High values were also noted in Wielkopolskie (18.9 thousand, 13.0 thousand and 18.2 thousand) and Małopolskie (18.1 thousand, 16.0 thousand and 19.7 thousand).




Chart 2. Residential construction by voivodships in the period of January - October 2023
