# The Census Hub: a new, easy and flexible way to access population and housing census data from all EU countries

How many single parent families live in your area? How many residents in your area were born abroad? When did they arrive in the country? What proportion of dwellings in your area are over 50 years old? And how many of these are unoccupied? How does your area compare with other parts of Europe? There is now an easy and flexible way to get answers to these questions: the Census Hub<sup>1</sup>. It provides detailed information to find out more about individuals, families, households and housing in your country, region and even town.

The 2011 Census Programme is an innovative project of the European Statistical System<sup>2</sup> (ESS). For the first time, Eurostat, together with ESS members, has set up an on-line application, called the Census Hub, that enables users to access census data stored in each EU Member State via a single entry point on the Eurostat website. The Census Hub provides access to a huge and uniquely rich source of data, based on the national census exercises undertaken in EU Member States and EFTA countries during the year 2011, providing information at a detailed geographical level, down to individual municipalities. Users can build their own tables by combining data for different countries and at different scales. This was simply not possible in the past, when only highly aggregated data were available.

On the occasion of the opening of the Census Hub and to illustrate the diversity of the information that can be retrieved from this innovative tool, Eurostat, the statistical office of the European Union, presents in this News Release a small selection of indicators about population, family composition and housing at different geographical levels<sup>3</sup>

#### One third of elderly people in Luxembourg do not live in a private household

With 32.9% of people aged 85 and over not living in private households, Luxembourg had the highest share among the EU Member States in 2011, followed by Malta (29.7%), Ireland (22.6%), the Netherlands (22.4%), Belgium (21.0%) and France (20.8%). At the opposite end of the scale, more than 95% of elderly people lived in private households in Romania (1.3% not living in private households), Bulgaria (1.7%), Poland (2.6%), Lithuania (3.0%), Latvia (4.0%) and Greece (4.2%). In the Census Hub, this kind of information is also available at detailed regional level.

### Share of people aged 85 and over not living in private households\* in the EU, 2011


# Highest proportion of lone parent families in the French department of Martinique, lowest in the Dutch region of Noord-Overijssel

At country level in 2011, the lowest proportions of lone parent families were to be found in Cyprus (9.9% of all families), the Netherlands (10.6%), Denmark (12.2%) and Germany (12.7%). With 1 in every 3 families being a lone parent family, Latvia (33.4%) recorded the highest proportions of lone parent families in the EU, followed by Slovenia (25.2%), Lithuania (24.4%), Estonia (23.8%) and Poland (22.2%).

At a detailed regional level, the highest share of lone parents in the EU in 2011 was registered in the French overseas department of Martinique (40.1% of all families), and the lowest in the Dutch region of Noord-Overijssel (7.7%). Among the 20 NUTS 3 regions in the EU with the highest shares of lone parent families, six were located in Latvia (Riga, Vidzeme, Zemgale, Pieriga, Latgale and Kurzeme, meaning all the Latvian NUTS 3 regions), five in the United Kingdom (Belfast, Liverpool, Glasgow, Inner London - East and Birmingham), four in France (the overseas departments of Martinique, Guadeloupe, Guyane and La Réunion), three in Poland (Miasto Lódz, Miasto Wroclaw and Walbrzyski) and two in Slovenia (Podravska and Obalno-Kraska).

<sup>\*</sup> non-private households mainly refer to collective institutions, but can also include the primary homeless persons and others not living as part of a private household.

#### Did you know that census data are also available for almost 125 000 municipalities?

The Census Hub enables people to learn more about their town or municipality. Data on persons, families, households and their housing are available for 123 189 local administrative units throughout Europe. Did you know for instance that people aged 85 and over represented 4% of the population in Salamanca? Did you know that more than half of households in Amsterdam consisted of a single person? That there were 1 661 families of 6 and more persons in Malmö? Did you know that 67% of the families in Hamburg were married couple families, and that almost 5% of all families in Antwerp were lone father families? Did you know that around 2 in every 3 dwellings in Saint-Tropez were secondary/holiday dwellings? And that 93% of dwellings in Tallinn are part of multi-dwelling buildings? These facts and many more can be easily retrieved from the EU 2011 Census Hub.
