Increase in prices of residential premises compared to the 3rd quarter of 2022

Prices of residential premises in the third quarter of 2023, compared to the second quarter of 2023, increased by 4.5% with the price increase on the primary market (by 4.0%) and secondary market (by 5.0%). Compared to the corresponding quarter of 2022, prices of residential premises increased by 9.3% (of which on the primary market - by 9.8% and on the secondary market - by 8.8%).

For compiling price indices of residential premises in 2023, the primary market is assigned a weight of 51.8% and the secondary market – 48.2%

Chart 2. Quarterly changes in prices of residential premises compared to the previous quarter




Chart 3. Quarterly changes in prices of residential premises compared to the corresponding quarter of the previous year





Chart 4. Quarterly changes in prices of residential premises compared to 2015



Prices of residential premises in the third quarter of 2023 were by 82.9% higher compared to the average price for 2015 (of which on the primary market – by 69.9% and on the secondary market – by 94.1%)

In the 3rd quarter of 2023, compared to the previous quarter, the highest increase in prices of residential premises was recorded in the Lubuskie Voivodship (by 7.2%), but the lowest price increase was observed in the Zachodniopomorskie Voivodship (by 1.6%)
