

Price indices of residential premises in the fourth quarter of 2024




In the fourth quarter of 2024 prices of residential premises in Poland compared to the third quarter of 2024, increased by 1.2%. On the primary market the increase was 1.1%, while on the secondary market it was 1.3%. Compared to the corresponding quarter of 2023, prices of residential premises increased by 10.4% (of which on the primary market – by 11.0% and on the secondary market – by 9.8%).

For compiling price indices of residential premises in 2024, the primary market is assigned a weight of 50.6% and the secondary market 49.4%

Chart 2. Changes in prices of residential premises compared to the previous quarter




Chart 3. Changes in prices of residential premises compared to the corresponding quarter of the previous year





Chart 4. Changes in prices of residential premises compared to 2015



In the fourth quarter of 2024 prices of residential premises were by 111.6% higher compared to the average price for 2015 (of which on the primary market – by 100.4% and on the secondary market – by 120.1%)

In the fourth quarter of 2024, the highest increase in prices of residential premises, compared to the previous quarter, was recorded in both the Lubelskie Voivodship and Wielkopolskie Voivodship (by 2.5%), while the highest price decrease was observed in the Podkarpackie Voivodship (by 1.8%)
