Increase in producer prices for business services compared to the second quarter of 2023 In the third quarter of 2023, the producer prices for business services increased compared to the previous quarter by 1.3% and compared to the third quarter of 2022 by 7.4%.

In the third quarter of 2023, an increase in prices compared to the previous quarter was recorded in most of the surveyed kinds of business services. The highest increase occurred in office administrative, office support and other business support activities, i.e. by 2.8% (i.a. an increase in the prices of office administrative services, services of call centres and services related to organisation of conventions and trade shows). Subsequently, an increase in the prices of services in programming and broadcasting activities (by 2.7%), travel agency, tour operator reservation service and related activities (by 2.5%). Significantly rose also the prices in other professional, scientific and technical activities (by 2.3%) and in architectural and engineering activities; technical testing and analysis (by 2.0%) of which architectural and engineering activities (by 2.3%). The lowest increase occured in computer programming, consultancy and related activities (by 0.3%), publishing activities (by 0.6%), as well as rental and leasing activities (by 0.7%). Whereas, the decrease in prices compared to the second quarter of 2023 was recorded in motion picture, video and television programme production, sound recording and music publishing activities (by 0.3%).

Compared to the third quarter of 2022, the highest increase of prices occurred in travel agency, tour operator reservation service and related activities (by 14.7%). Subsequently, the increase in prices was noticed in other professional, scientific and technical activities as well as in security and investigation activities (by 13.5%).

Whereas, the lowest increase of prices compared to the third quarter of previous year was recorded in the case of programming and broadcasting activities (by 1.2%).

In the third quarter of 2023 the highest increase of prices compared to the previous quarter occurred in office administrative, office support and other business support activities, i.e. by 2.8%.

Chart 1. Producer price changes of business services in 2020-2023 (the previous quarter = 100)





Chart 2. Producer price changes of business services in 2020-2023 (corresponding period of the previous year = 100)
