According to preliminary data, in January 2022 consumer prices increased by 9,2% compared with the corresponding month of the previous year. As related to the previous month consumer prices increased by 1,9%.

Chart 1. Consumer prices^b (change in % compared with the previous period)

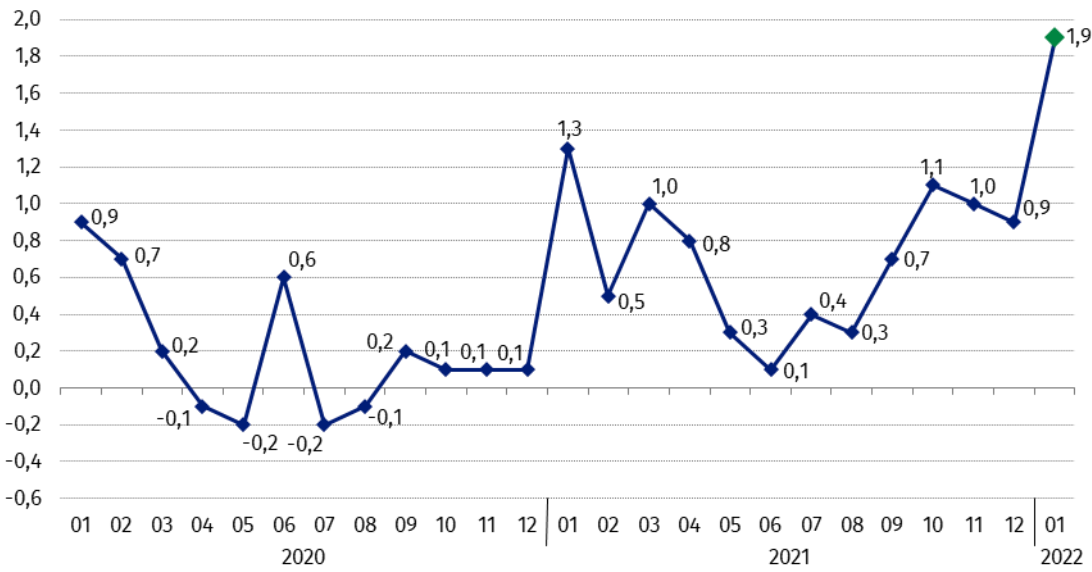
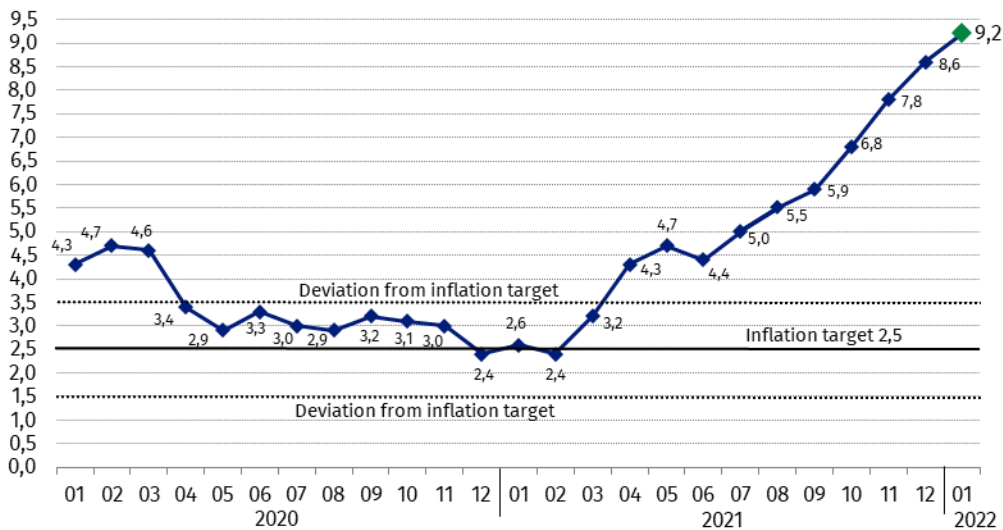


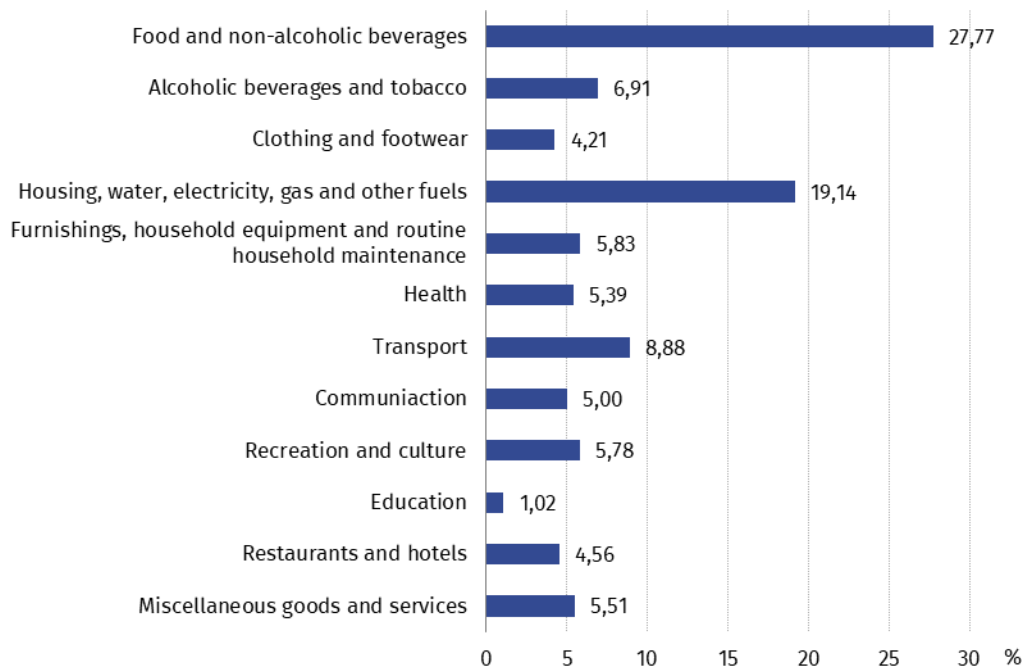
Chart 2. Consumer prices^b (change in % compared with the corresponding period of the previous year)
