

Price indices of sold production of industry in May 2021

According to preliminary data, in May 2021 the prices of sold production of industry increased compared to April 2021 by 0.8 % and compared to that recorded in the corresponding month of the previous year - by 6.5%.

According to preliminary data, the prices of sold production of industry in May 2021 were higher by 0.8% compared to April 2021. Prices growth was recorded in all sections of the industry. The highest growth of prices was recorded in the section mining and quarrying by 3.5%, of which in mining of metal ores- by 5.9% as well as in mining of coal and lignite by 1.8%. The prices in the section manufacturing increased by 0.7%, with multidirectional price changes in individual divisions. The prices the most increased in manufacture of coke and refined petroleum products (by 3.1%). The prices growth was recorded also, among others, in manufacture: of basic metals (by 2.3%), of products of wood, cork, straw and wicker (by 1.3%), of rubber and plastic products (by 0.9%), of paper and paper products as well as of chemicals and chemical products (by 0.8% each), of food products (by 0.7%), of metal products (by 0.6%), of beverages (by 0.5%), of other non-metallic mineral products (by 0.3%), of printing and reproduction of recorded media as well as of electrical equipment (by 0.2% each). The prices in manufacture of machinery and equipment as well as in manufacture of motor vehicles, trailers and semi-trailers remained at a level similar to that recorded in the previous month. However, the prices decreased, among other things, in manufacture: of tobacco products as well as of textiles and of furniture (by 0.1% each), of leather and related products (by 0.2%), of wearing apparel as well as of pharmaceutical products (by 0.3% each), of computer, electronic and optical products and of other transport equipment (by 0.4% each). The prices in sections electricity, gas, steam and air conditioning supply as well as water supply; sewerage, waste management and remediation activities increased respectively by 0.5% and by 0.4%.

In May 2021 the prices of sold production of industry compared to May 2020 increased by 6.5%. Prices growth was recorded in all sections of the industry. The prices the most increased in the section **mining and quarrying -** by 25.0%, of which in mining of metal ores by 64.6%, with the prices drop in mining of coal and lignite - by 0.4%. The prices in **manu**facturing increased by 6.3%, with multidirectional prices movements in individual divisions. The prices the most increased in manufacture of coke and refined petroleum products (by 70.6%). The prices were also higher than in the year before, among other things, in manufacture: of basic metals (by 19.6%), of chemicals and chemical products (by 10.5%), of products of wood, cork, straw and wicker (by 6.0%), of rubber and plastic products (by 4.1%), of food products (by 3.5%), of metal products (by 3.3%), of paper and paper products (by 2.6%), of pharmaceutical products (by 2.5%), of computer, electronic and optical products (by 2.3%), of beverages as well as of motor vehicles, trailers and semi-trailers (by 1.7% each). of other transport equipment (by 1.5%), of furniture (by 1.0%), of other non-metallic mineral products and of electrical equipment (by 0.9% each). However, the prices decreased, among other things, in manufacture: of leather and related products (by 0.4%), of textiles (by 0.5%), of machinery and equipment (by 0.8%), of printing and reproduction of recorded media (by 1.2%), of tobacco products (by 1.4%). The deepest drop of prices compared to May 2020 was recorded in manufacture of wearing apparel (by 3.5%). The prices in the section water supply; sewerage, waste management and remediation activities increased in annual term by 3.6% and in the section electricity, gas, steam and air conditioning supply - by 3.1%.

Among divisions of manufacturing in May 2021 the prices the most increased in manufacture of coke and refined petroleum products both in comparison with the previous month as well as in annual term




Chart 1. Prices changes of sold production of industry in 2020-2021 in relation to the previous period (in %)

Chart 2. Prices changes of sold production of industry in 2020-2021 in relation to the same period of the previous year (in %)





Chart 3. Prices changes of sold production of industry by sections NACE in 2020-2021 in relation to December 2019 (in %)
