

Foreign trade turnover of goods in total and by countries in January - December 2023

Foreign trade turnover¹ in January - December 2023 (based on temporary data²) in exports at current prices amounted to PLN 1 604.1 bn, while in imports - PLN 1 555.4 bn. The positive balance reached the level of PLN 48.6 bn, while in the same period of 2022 year was negative and amounted to PLN 93.2 bn. In comparison to the corresponding period of last year exports decreased by 0.9%, and imports by 9.1%.

Foreign trade turnover expressed in US dollars and in EUR

Exports expressed in USD amounted to 379.7 bn, while imports amounted to USD 368.3 bn (an increase in exports of 3.8% and decrease in imports of 4.8%). The positive balance reached the level of USD 11.4 bn, while in the same period of 2022 year was negative and amounted to USD 21.2 bn.

Exports expressed in EUR amounted to 351.0 bn, while imports amounted to EUR 340.5 bn (an increase in exports of 1.4% and decrease in imports of 7.0%). The positive balance reached EUR 10.6 bn, compared to a negative balance of EUR 20.0 bn in the same period of 2022.

Foreign trade turnover of goods in total and by groups of countries

Poland has the largest share in total exports with the developed countries – 86.5% (of which EU 74.7%) and in imports – 65.9% (of which EU 53.9%), in comparison with 87.3% (of which EU 75.8%) and 62.2% (of which EU 51.4%) in the corresponding period of 2022. However, the smallest share was observed with the countries of Central and Eastern Europe, which in total exports amounted to 5.2%, and in imports – 2.2%, in comparison with 4.8% and 6.2% in January - December 2022.

The negative balance was recorded with the developing countries – minus PLN 362.6 bn (minus USD 85.8 bn, minus EUR 79.4 bn). The positive balance was obtained in turnover with other groups of countries, i.e. Central and Eastern Europe PLN 48.3 bn (USD 11.5 bn, EUR 10.6 bn) and with developed countries PLN 362.9 bn (USD 85.7 bn, EUR 79.3 bn), of which with the EU countries the balance of PLN 360.3 bn (USD 85.1 bn, EUR 78.7 bn).

Note. Due to the rounding of data, in some cases sums of components may slightly differ from the amount given in the item "total".

¹Collection of data on foreign trade turnover is open. Data published formerly is updated according to new customs and INTRASTAT declarations. Data for January - December 2023 have been amended to include unregistered customs declarations for earlier months of this year.

Foreign trade turnover by major countries

In January - December 2023 among the main trade partners of Poland increases in exports were observed compared to January - December 2022, except Slovakia where exports decreased by 6.9%, Czechia by 6.0%, the Netherlands by 3.1%, Italy by 1.4% and Germany by 0.6%. However, in January - December 2023 in comparison with the same period of 2022, imports decreased with China by 14.2%, Germany by 10.8%, the United States by 7.3%, Belgium by 6.3%, Italy by 5.6%, Czechia by 3.8%, and Netherlands by 2.2%.

The turnover with the top ten of Polish trade partners in exports accounted for 66.1% (65.6% in the same period of 2022 year), while in total imports – 61.1% (in comparison with 59.6% in January - December 2022).

The share of Germany in exports in comparison with the corresponding period of 2022 year remained at 27.9% and in imports decreased by 0.4 pp and accounted for 19.8%. The positive balance amounted to PLN 140.1 bn (USD 33.1 bn, EUR 30.6 bn) in comparison with PLN 105.6 bn (USD 23.7 bn, EUR 22.5 bn) in the same period of 2022.

³ Country of origin is the country where the commodity was produced or processed and in this form entered the Polish customs zone.

Imports by country of consignment – total and groups of counties

The highest turnover in imports by country of consignment Poland recorded with the developed countries - PLN 1 189.6 bn, of which with the EU - PLN 1 056.9 bn, compared to PLN 1 229.9 bn, of which with the EU - PLN 1 097.9 bn in the same period of 2022.

Imports by country of consignment – countries

The share of Germany in imports by country of consignment in comparison with imports by country of origin was higher by 5.6 pp, the share of the Netherlands by 2.6 pp, Belgium by 1.8 pp, Czechia by 0.9 pp and France by 0.5 pp.

⁴ Country of consignment is the country from which the goods were introduced into the Polish territory irrespective of their origin.

In January - December 2023 trade turnover in goods according to the SITC nomenclature compared to the same period in 2022, both in exports and imports increased in three commodity sections.

In exports the largest increase concerned beverages and tobacco (by 17.9%), machinery and transport equipment (by 5.7%), and food and live animals (by 4.7%). The decrease concerned commodities and transactions not classified in SITC (by 34.4%), mineral fuels, lubricants and related materials (by 19.2%), crude materials inedible except fuels (by 15.7%), animal and vegetable oils, fats and waxes (by 10.6%), manufactured goods classified chiefly by material (by 9.1%), chemicals and related products (by 8.5%) and miscellaneous manufactured articles (by 0.2%).

In imports an increase was recorded in beverages and tobacco (by 13.8%), food and live animals (by 4.0%) and machinery and transport equipment (by 2.8%). The largest decrease was recorded in commodities and transactions not classified elsewhere in SITC (by 61.0%), vegetable oils, fats and waxes (by 28.2%), crude materials inedible, except fuels (by 20.5%), mineral fuels, lubricants and related materials (by 16.6%), manufactured goods classified chiefly by material (by 16.2%), chemicals and related products (by 11.2%), and miscellaneous manufactured articles (by 7.2%).

Chart 1. Composition of exports by sections according to SITC nomenclature in January - December 2023





Chart 2. Composition of imports by sections according to SITC nomenclature in January - December 2023
