Foreign trade turnover of goods in total and by countries in January - March 2024

Foreign trade turnover¹ in January - March 2024 in exports at current prices amounted to PLN 376.8 bn, while in imports - PLN 361.7 bn. The positive balance reached the level of PLN 15.1 bn, while in the same period of 2023 year amounted to PLN 15.2 bn. In comparison to the corresponding period of last year exports decreased by 12.4%, and imports by 12.8%.

Foreign trade turnover expressed in US dollars and in EUR

Exports expressed in USD amounted to 94.5 bn, while imports amounted to USD 90.7 bn (a decrease in exports of 3.6% and in imports of 4.1%). The positive balance reached the level of USD 3.8 bn, while in the same period of 2023 amounted to USD 3.5 bn.

Exports expressed in EUR amounted to 86.8 bn, while imports amounted to EUR 83.3 bn (a decrease in exports of 4.9% and in imports of 5.4%). The positive balance reached EUR 3.5 bn, compared to the positive balance of EUR 3.2 bn in the same period of 2023.

Foreign trade turnover of goods in total and by groups of countries

Poland has the largest share in total exports with the developed countries – 86.3% (of which EU 73.8%) and in imports – 66.8% (of which EU 54.9%), in comparison with 87.5% (of which EU 76.2%) and 65.2% (of which EU 53.8%) in the corresponding period of 2023. However, the smallest share was observed with the countries of Central and Eastern Europe, which in total exports amounted to 5.2%, and in imports – 2.1%, in comparison with 4.7% and 3.1% in January - March 2023.

The negative balance was recorded with the developing countries – minus PLN 80.6 bn (minus USD 20.2 bn, minus EUR 18.6 bn). The positive balance was obtained in turnover with other groups of countries, i.e. Central and Eastern Europe PLN 12.3 bn (USD 3.1 bn, EUR 2.8 bn) and with developed countries PLN 83.4 bn (USD 20.9 bn, EUR 19.2 bn), of which with the EU countries the balance of PLN 79.5 bn (USD 20.0 bn, EUR 18.3 bn).

Note. Due to the rounding of data, in some cases sums of components may slightly differ from the amount given in the item "total".

Foreign trade turnover by major countries

In January - March 2024 among the main trade partners of Poland decreases in exports were observed compared to January - March 2023, except Ukraine where exports increased by 5.8%. In January - March 2024 in comparison with the same period of 2023, only decreases in imports were reported.

The turnover with the top ten of Polish trade partners in exports accounted for 66.4% (66.8% in the same period of 2023 year), while in total imports – 61.6% (in comparison with 60.0% in January - March 2023).

The share of Germany in exports in comparison with the corresponding period of 2023 year decreased by 1.5 pp and amounted to 27.2% while in imports increased by 0.3 pp and accounted for 20.3%. The positive balance amounted to PLN 29.0 bn (USD 7.3 bn, EUR 6.7 bn) in comparison with PLN 40.4 bn (USD 9.2 bn, EUR 8.6 bn) in the same period of 2023.

² Country of origin is the country where the commodity was produced or processed and in this form entered the Polish customs zone.

Imports by country of consignment – countries

The share of Germany in imports by country of consignment in comparison with imports by country of origin was higher by 5.7 pp, the share of the Netherlands by 2.6 pp, Belgium by 1.9 pp, Czechia by 1.1 pp and France by 0.5 pp.

³ Country of consignment is the country from which the goods were introduced into the Polish territory irrespective of their origin.

In January - March 2024 trade turnover in goods according to the SITC nomenclature compared to the same period in 2023, both in exports and imports decreased in all commodity sections.

Exports decreased in commodities and transactions not classified in SITC (by 25.9%), mineral fuels, lubricants and related materials (by 21.7%), manufactured goods classified chiefly by material (by 15.5%), crude materials inedible except fuels (by 15.4%), chemicals and related products (by 12.7%), machinery and transport equipment (by 12.0%), food and live animals (by 10.6%), animal and vegetable oils, fats and waxes (by 10.4%), beverages and tobacco (by 9.5%), and miscellaneous manufactured articles (by 9.0%).

In imports decreases were recorded in commodities and transactions not classified elsewhere in SITC (by 47.3%), mineral fuels, lubricants and related materials (by 34.7%), vegetable oils, fats and waxes (by 23.2%), crude materials inedible, except fuels (by 15.0%), manufactured goods classified chiefly by material (by 13.9%), chemicals and related products (by 13.4%), food and live animals (by 7.6%), machinery and transport equipment (by 7.4%), beverages and tobacco (by 6.0%) and miscellaneous manufactured articles (by 4.2%).

Chart 1. Composition of exports by sections according to SITC nomenclature in January - March 2024





Chart 2. Composition of imports by sections according to SITC nomenclature in January - March 2024
