

# Foreign trade turnover of goods in total and by countries in January - April 2024

14.06.2024



Foreign trade turnover¹ in January - April 2024 in exports at current prices amounted to PLN 505.6 bn, while in imports - PLN 487.2 bn. The positive balance reached the level of PLN 18.4 bn, while in the same period of 2023 year amounted to PLN 18.3 bn. In comparison to the corresponding period of last year exports decreased by 9.9%, and imports by 10.3%.

# Foreign trade turnover expressed in US dollars and in EUR

Exports expressed in USD amounted to 126.8 bn, while imports amounted to USD 122.1 bn (a decrease in exports of 1.1% and in imports of 1.5%). The positive balance reached the level of USD 4.6 bn, while in the same period of 2023 amounted to USD 4.2 bn.

Exports expressed in EUR amounted to 116.6 bn, while imports amounted to EUR 112.3 bn (a decrease in exports of 2.2% and in imports of 2.6%). The positive balance reached EUR 4.2 bn, compared to the positive balance of EUR 3.9 bn in the same period of 2023.

# Foreign trade turnover of goods in total and by groups of countries

Poland has the largest share in total exports with the developed countries – 86.4% (of which EU 73.9%) and in imports – 66.4% (of which EU 54.6%), in comparison with 87.2% (of which EU 75.8%) and 65.3% (of which EU 53.8%) in the corresponding period of 2023. However, the smallest share was observed with the countries of Central and Eastern Europe, which in total exports amounted to 5.2%, and in imports – 2.0%, in comparison with 4.7% and 2.9% in January – April 2023.

The negative balance was recorded with the developing countries – minus PLN 111.1 bn (minus USD 27.9 bn, minus EUR 25.6 bn). The positive balance was obtained in turnover with other groups of countries, i.e. with developed countries PLN 113.1 bn (USD 28.4 bn, EUR 26.1 bn), of which with the EU countries the balance of PLN 107.6 bn (USD 27.0 bn, EUR 24.8 bn) and Central and Eastern Europe PLN 16.4 bn (USD 4.1 bn, EUR 3.8 bn).

Note. Due to the rounding of data, in some cases sums of components may slightly differ from the amount given in the item "total".

# Foreign trade turnover by major countries

In January - April 2024 among the main trade partners of Poland decreases in exports were observed compared to January - April 2023, except Ukraine where exports increased by 9.1%, United Kingdom by 2.1% and the United States by 0.5%. In January - April 2024 in comparison with the same period of 2023, imports increased with the United States by 1.2%.

The turnover with the top ten of Polish trade partners in exports accounted for 66.4% (66.2% in the same period of 2023 year), while in total imports – 61.4% (in comparison with 60.2% in January - April 2023).

The share of Germany in exports in comparison with the corresponding period of 2023 year decreased by 1.2 pp and amounted to 27.2% while in imports increased by 0.2 pp and accounted for 20.1%. The positive balance amounted to PLN 39.3 bn (USD 9.9 bn, EUR 9.1 bn) in comparison with PLN 51.3 bn (USD 11.7 bn, EUR 10.9 bn) in the same period of 2023.

# Imports by country of consignment – total and groups of counties

The highest turnover in imports by country of consignment Poland recorded with the developed countries - PLN 374.1 bn, of which with the EU - PLN 335.4 bn, compared to PLN 410.3 bn, of which with the EU - PLN 365.0 bn in the same period of 2023.

# Imports by country of consignment - countries

The share of Germany in imports by country of consignment in comparison with imports by country of origin was higher by 5.7 pp, the share of the Netherlands by 2.4 pp, Belgium by 1.9 pp, Czechia by 1.0 pp and France by 0.5 pp.

In January - April 2024 trade turnover in goods according to the SITC nomenclature compared to the same period in 2023 decreased in exports in all commodity sections. In imports trade turnover in goods increased in one commodity section.

Exports decreased in mineral fuels, lubricants and related materials (by 22.0%), commodities and transactions not classified in SITC (by 13.8%), crude materials inedible except fuels (by 13.7%), manufactured goods classified chiefly by material (by 12.6%), chemicals and related products (by 10.1%), machinery and transport equipment (by 9.7%), food and live animals (by 8.0%), miscellaneous manufactured articles (by 6.5%), animal and vegetable oils, fats and waxes (by 4.9%) and beverages and tobacco (by 4.7).

In imports an increase concerned beverages and tobacco (by 0.8%). The largest decreases were recorded in commodities and transactions not classified elsewhere in SITC (by 41.6%), mineral fuels, lubricants and related materials (by 29.0%), vegetable oils, fats and waxes (by 16.6%), crude materials inedible, except fuels (by 13.9%), chemicals and related products (by 13.0%), manufactured goods classified chiefly by material (by 11.9%), machinery and transport equipment (by 5.1%), food and live animals (by 4.8%) and miscellaneous manufactured articles (by 1.9%).

Chart 1. Composition of exports by sections according to SITC nomenclature in January - April 2024





Chart 2. Composition of imports by sections according to SITC nomenclature in January - April 2024
