**Foreign trade turnover in total and by countries ¹
in January - February 2016**

From January to February of 2016, exports at current prices amounted to PLN 123372.2 mln, while imports amounted to PLN 117608.3 mln. The positive balance reached the level of PLN 5763.9 mln, while in the previous year PLN 4547.3 mln. In comparison to the corresponding period of the 2015, exports increased by 4.1% and imports by 3.2%.

Exports expressed in USD amounted to 30902.1 mln while imports amounted to USD 29458.0 mln (a decline of 5.2% and 6.1% respectively). The positive balance reached the level of USD 1444.1 mln (against USD 1228.9 mln from January to February 2015).

Exports expressed in EUR amounted to 28289.3 mln while imports amounted to EUR 26972.0 mln (an increase in exports of 3.0% and in imports of 2.1%). The positive balance reached the level of EUR 1317.3 mln compared to EUR 1047.7 mln in the same period last year.
