**Foreign trade turnover in total and by countries ¹
in January - March 2016**

From January to March of 2016, exports at current prices amounted to PLN 191948.5 mln, while imports amounted to PLN 183629.5 mln. The positive balance reached the level of PLN 8319.0 mln, while in the previous year PLN 6337.8 mln. In comparison to the corresponding period of the 2015, exports increased by 4.2% and imports by 3.2%.

Exports expressed in USD amounted to 48279.5 mln while imports amounted to USD 46185.2 mln (a decline of 4.2% and 5.1% respectively). The positive balance reached the level of USD 2094.3 mln (against USD 1714.9 mln from January to March 2015).

Exports expressed in EUR amounted to 43903.8 mln while imports amounted to EUR 42004.7 mln (an increase in exports of 1.7% and in imports of 0.8%). The positive balance reached the level of EUR 1899.1 mln compared to EUR 1483.7 mln in the same period last year.
