**Foreign trade turnover of goods in total and by countries ¹
in January – July 2016**

From January to July of 2016, exports at current prices amounted to PLN 455339.5 mln, while imports amounted to PLN 436501.5 mln. The positive balance reached the level of PLN 18838.0 mln, while in the previous year PLN 7158.9 mln. In comparison to the corresponding period of the 2015, exports increased by 5.6% and imports by 3.0%.

Exports expressed in USD amounted to 116793.0 mln while imports amounted to USD 111938.3 mln (an increase in exports of 0.3% and in imports decline of 2.2%). The positive balance reached the level of USD 4854.7 mln (against USD 1957.0 mln from January to July 2015).

Exports expressed in EUR amounted to 104694.0 mln while imports amounted to EUR 100357.1 mln (an increase in exports of 1.1% and in imports decline of 1.4%). The positive balance reached the level of EUR 4336.9 mln compared to EUR 1711.3 mln in the same period last year.
