**Foreign trade turnover of goods in total and by countries <sup>1</sup>  
in January – September 2016**

After three quarters of 2016, exports at current prices amounted to PLN 586321.2 mln, while imports amounted to PLN 568375.8 mln. The positive balance reached the level of PLN 17945.4 mln, while in the previous year PLN 6993.7 mln. In comparison to the corresponding period of the 2015, exports increased by 5.8% and imports by 3.9%.

**Exports expressed in USD** amounted to 150441.3 mln while imports amounted to USD 145813.2 mln (an increase in exports of 0.9% and in imports decline of 1.0%). The positive balance reached the level of USD 4628.1 mln (against USD 1907.4 mln from January to September 2015).

**Exports expressed in EUR** amounted to 134850.2 mln while imports amounted to EUR 130716.0 mln (an increase in exports of 1.2% and in imports decline of 0.6%). The positive balance reached the level of EUR 4134.2 mln compared to EUR 1668.7 mln in the same period last year.
