

Foreign trade turnover of goods in total and by countries in January – March 2019



Foreign trade turnover¹ in the first quarter of this year according to exports at current prices amounted to PLN 243.7 bn, while imports amounted to PLN 244,8 bn. The negative balance reached the level of PLN 1.1 bn, while in the same period last year amounted to minus PLN 5.8 bn. In comparison to the corresponding period of the 2018, exports increased by 7.6%, and imports by 5.4%.

Foreign trade turnover expressed in US dollars and in EUR

Exports expressed in USD amounted to 64.4 bn USD while imports amounted to USD 64.7 bn (a decrease in exports of 2.6% and in imports of 4.6%). The negative balance reached the level of USD 0,3 bn, while the same period last year amounted minus USD 1.7 bn.

Exports expressed in EUR amounted to 56.6 bn while imports amounted to EUR 56.9 bn (an increase in exports of 4.4% and in imports of 2.2%). The negative balance reached the level of EUR 0,3 bn and minus EUR 1.4 bn in the same period in 2018.




Chart 1. Turnover in the last three months in PLN billion

Foreign trade turnover of goods in total and by groups of countries

Poland has the largest share in total exports with developed countries – 87.4% (of which EU 80.5%), and imports – 66.3% (of which EU 58.8%), as against 87.7% (of which EU 81.2%) and 67.0% (of which EU 60.0%) in the corresponding period of the previous year. However, the smallest share was observed in the countries of Central and Eastern Europe, which in total exports amounted to 5.6%, and in imports – 7.9%, as against 5.3% and 8.6% in January – March 2018.

The high share of developed countries in trade in goods is affected by high turnover with the EU

The negative balances were recorded with developing countries – minus PLN 46,1 bn (minus USD 12.2 bn, minus EUR 10.8 bn) and with countries Central and Eastern Europe – minus PLN 5.6 bn (minus USD 1.5 bn, minus EUR 1.3 bn). The positive balance was obtained in turnover with developed countries PLN 50.6 bn (USD 13.4 bn, EUR 11.8 bn), of which EU countries a balance of PLN 52.2 bn (USD 13.8 bn, EUR 12.1 bn).

Foreign trade turnover by major countries

In the first quarter of this year among the main trade partners of Poland there was an increase in exports to all counters from top ten and in imports – from United States, China, Spain, and Germany.

The turnover with the top ten of Polish trade partners in exports as in the corresponding period of the previous year accounted for 66.8%, while total imports – 64.1% (against 65.5% after three months of 2018).

The share of Germany in exports decreased in comparison with the corresponding period of last year by 1.2 pp and amounted to 27.0%, and imports has decreased by 0.1 pp and accounted for 22.7%. The positive balance amounted to PLN 10.4 bn (USD 2.7 bn, EUR 2.4 bn) against PLN 10.9 bn (USD 3.2 bn, EUR 2.6 bn) in the same period of 2018.

² Country of origin is the country where the commodity was produced or processed and in this form entered the Polish customs zone.

The share of Russia in imports decreased by 0.9 pp compared to the same period of 2018 and it was 6.0%

Imports by country of consignment in total and by groups of counties

The highest turnover in imports by country of consignment Poland recorded with the developed countries - PLN 180.2 bn, of which the EU – PLN 168.2 bn, compared to PLN 175.0 bn, of which the EU - PLN 164.9 bn in the same period of 2018.

Imports by country of consignment – by countries

The share of Germany in imports by country of consignment to imports by country of origin was higher by 4.2 pp, accordingly the share of the Netherlands was higher by 1.7 pp, Belgium by 1.4 pp, Czech Republic by 0.6 pp and Russia by 0.4 pp.
