## Retail sales index - June 2023

## 4.7\%

A decrease compared with the corresponding month of the previous year

In June 2023 retail sales ${ }^{1}$ at constant prices were by $4.7 \%$ lower than the year before (against an increase of $3.2 \%$ in June 2022).
Compared with May 2023 an increase by $0.9 \%$ in retail sales was recorded.
In the period of January-June ${ }^{2} 2023$ sales decreased y/y by 5.7\% (in 2022 a growth of 9.1\%).

## Retail sales of goods by type of enterprise activity

In June 2023, the largest decrease in retail sales (at constant prices) compared with the corresponding period of 2022 was maintained in units from the group "newspapers, books, other sale in specialized stores" (by $16.6 \%$ against a decrease of $2.3 \%$ the year before). A significantly drop in sales was also recorded in the groups: "furniture, radio, TV and household appliances" (by 14.4\%), "others" (by 12.6\%), "solid, liquid and gaseous fuels" (by 8.3\%). Units trading in food, beverages and tobacco products noted a decline by 3.8\%.

In June compared with May 2023, a decrease in retail sales value via Internet at current prices was recorded (by $8.9 \%$ ). The share of sales via Internet in "total" sales decreased from $8.5 \%$ in May to 7.7\% in June 2023. Among the presented groups with a significant share of sales via Internet a decrease in share was reported by enterprises classified in the groups: "textiles, clothing, footwear" (from $22.6 \%$ a month ago to $16.9 \%$ ), "newspapers, books, other sale in specialized stores" (from $22.2 \%$ to $21.2 \%$ respectively) and "furniture, radio, TV and household appliances" (from 15.1\% to 14.4\%).

[^0]In June 2023, a decrease in retail sales (at constant prices) y/y was recorded in all presented groups, except for the group of "pharmaceuticals, cosmetics, orthopaedic equipment", in which sales remained at the previous year's level

## Retail sales seasonally adjusted

After eliminating the seasonal factors, retail sales at constant prices in June 2023 were by $0.6 \%$ higher compared with May 2023.

Groups of enterprises were created on the basis of the Polish Classification of Activities (PKD 2007) and a given enterprise is included to a specific category by predominating kind of activity and according to its present organizational status in mentioned period. The recorded changes of rise or fall of the volume of retail sales in particular groups of enterprises activity may result from a change in the predominating kind of activity and organisational changes (e.g. a merger of enterprises). This does not have impact on the dynamics of the total retail sales.
    ${ }^{2}$ Corrections made by reporting entities were included in cumulative data.
