

## Residential construction<sup>1</sup> in the period of January-July 2024

In the period of January-July 2024, there were less dwellings completed than the year before. Whereas the number of dwellings for which permits have been granted or which have been registered with a construction project as well as dwellings in which construction has begun increased.

### **Dwellings completed**

According to the preliminary data, 114.2 thousand dwellings were completed in the first seven months of 2024, i.e. by 9.9% less than in the corresponding period of 2023. Developers completed 69.9 thousand dwellings – by 5.8% less than a year ago, whereas private investors completed 41.0 thousand dwellings, i.e. by 18.8% less. Within these forms of construction, 97.1% of the total number of newly completed dwellings was built. Within other forms of construction 3.3 thousand dwellings were completed (2.1 thousand in the previous year).

The total useful floor area of dwellings completed amounted to 10.3 million  $m^2$ , i.e. by 13.0% less than a year ago and its average value for 1 dwelling was 90.1  $m^2$ .

# Dwellings for which permits have been granted or which have been registered with a construction project<sup>2</sup>

In the period of January-July 2024, permits and registrations have been granted for construction of 169.9 thousand dwellings, i.e. by 29.6% more than a year ago. Permits for construction of the biggest number of dwellings were given to developers (119.4 thousand, an increase of 39.2% y/y) and to private investors (46.8 thousand, an increase of 13.3%). Within these forms of construction, permits have been granted and registrations with a construction project were made for 97.8% of dwellings in total. In other forms of construction 3.7 thousand dwellings for which permits have been granted or which have been registered with a construction project were noted (4.1 thousand in the previous year).

#### **Dwellings in which construction has begun**

In the first seven months of 2024, the number of dwellings in which construction has begun was 142.3 thousand, i.e. by 39.8% more than a year before. Developers have started construction of 92.4 thousand dwellings (by 61.5% more y/y), and private investors of 47.5 thousand (by 12.4% more). Altogether the share of these forms of construction was 98.2% of the total number of dwellings. In other forms of construction the number of dwellings in which construction has begun was 2.5 thousand (2.4 in the previous year).




It is estimated that at the end of July 2024, there were 829.1 thousand dwellings under construction, i.e. by 2.6% more than in the corresponding month of 2023.

In the period of January-July 2024, the highest total number of dwellings completed, as well as dwellings in which construction has begun and dwellings for which permits have been granted or which have been registered with a construction project, were recorded in Mazowieckie voivodship (respectively: 20.7 thousand, 27.7 thousand and 35.0 thousand dwellings). High values were also noted in: Małopolskie (12.2 thousand, 12.8 thousand and 17.3 thousand), Wielkopolskie (10.4 thousand, 13.7 thousand and 16.1 thousand) and Dolnośląskie (9.2 thousand, 13.9 thousand and 15.4 thousand).

In July 2024, compared to the previous month, the number of dwellings in which construction has begun decreased (by 5.9%), whereas the number of dwellings for which permits have been granted or which have been registered with a construction project as well as the number of dwellings completed increased (respectively by 10.9% and 10.5%)
