

Financial results of cultural institutions in 2023 – preliminary data

Total revenue increase y/y

In 2023, the financial results of cultural institutions were higher in comparison to the previous year. Total revenues increased by 16.2%, total costs by 15.7% and investment outlays by 13.5%.

Total revenues of cultural institutions in 2023 amounted to PLN 14,396.7 million. In the structure of revenues, 91.5% were net revenues from sale of products, goods and materials, 8.2% - other operating revenues and 0.3% - financial revenues. More than 26.0% of revenues were the total revenues of cultural institutions from Mazowieckie Voivodship.

Average total revenues per one cultural institution amounted to PLN 3,056.6 thousand. The highest total revenues per one institution were achieved by cultural institutions in Mazowieckie Voivodship – PLN 5,754.6 thousand, and the lowest in Lubelskie Voivodship – PLN 1,476.3 thousand. In 2023 national cultural institutions achieved revenues of PLN 2,854.5 million, while revenues of local government cultural institutions amounted to PLN 11,542.2 million. In the total revenues of cultural institutions the largest share was held by entities operating arts facilities – 40.7%.

Total costs were higher by 15.7% than in the previous year and amounted to PLN 14,198.2 million. The structure of costs was composed of: operating costs (98.6%), other operating costs (1.3%) and financial costs (0.1%). As in the case of revenues, over 26.0% of total costs were the costs of cultural institutions in Mazowieckie Voivodship. In the total costs of cultural institutions, the largest share was held by entities operating arts facilities - 40.8%.

Gross financial result amounted to PLN 198.6 million (gross profit PLN 303.0 million, gross loss PLN 104.4 million). Net financial result amounted to PLN 196.6 million (PLN 117.3 million in the previous year), with an increase in net profit (by 19.8%) and decrease in net loss (by 21.9%).



In 2023 the investment outlays of cultural institutions were higher by 13.5% than in the previous year and amounted to PLN 2,181.0 million. Over 33.0% of investment outlays had cultural institutions from Mazowieckie voivodship.

Investment outlays incurred by local government cultural institutions amounted to PLN 1,316.9 million, i.e. 60.4% of the total amount of investment outlays.

Chart 1. The structure of investment outlays of cultural institutions by legal forms in 2023



In 2023 outlays of cultural institutions on intangible fixed assets were 54.2% higher in comparison to the previous year and amounted to PLN 51.9 million. The largest share of outlays on intangible fixed assets had cultural institutions from Mazowieckie Voivodship (48.0%).
