

Registrations and bankruptcies of enterprises in the second quarter of 2024

Decrease in the number of registrations of enterprises in the second quarter of 2024 compared to the corresponding period of previous year

In the second quarter of 2024, there were 87 642 registrations of enterprises recorded i.e. 1.0% less than in the corresponding period of previous year and 92 enterprises declared bankruptcy i.e. 5.2% less than in the second quarter of 2023.


Registrations of enterprises

The number of registrations of enterprises in the second quarter of 2024 amounted to 87 642 compared to 88 549 in the corresponding period of previous year. The greatest decrease was observed in: information and communication (by 20.8%) and trade; repair of motor vehicles (by 4.8%). An increase in the number of registrations of enterprises was recorded in construction (by 0.2%), services (by 4.8%) and other sections (by 7.5%).

Regarding the legal forms, in the second quarter of 2024, a decrease was observed in most of legal forms, including natural persons conducting economic activity (by 1.37%) and public limited partnerships (by 40.0%). An increase of registrations was noticed in the case of public limited companies (by 24.1%), professional partnerships (by 13.6%), limited liability companies (by 2.5%) and cooperatives (by 36.3%).


In the second quarter of 2024, 84.0% of all registrations of enterprises concerned natural persons conducting economic activity and 14.1% limited liability companies (in the second quarter of 2023 the shares were 84.3% and 13.7%, respectively).


Bankruptcies of enterprises

In the second quarter of 2024, a number of enterprises that declared bankruptcy amounted to 92 and was 5.2% lower than in the corresponding period of previous year. A decrease in the number of entities that declared bankruptcy was recorded in: industry (20 vs. 30), transportation and storage (4 vs. 7), accommodation and catering (3 vs. 5) and other section (3 vs. 10). An increase was noticed in construction (13 vs. 9), trade; repair of motor vehicles (26 vs. 18) and services (21 vs. 16). In information and communication the number of bankruptcies remained at the same level (2).

In terms of legal forms, a lower number of bankruptcies was recorded in: limited liability companies (70 vs. 72), natural persons conducting an economic activity (4 vs. 11), public limited companies (5 vs. 6) and cooperatives (0 vs. 1). A higher number of bankruptcies was recorded in limited partnerships (9 vs. 7), general partnerships (3 vs. 0) and public limited partnerships (1 vs. 0).


Among the enterprises for which bankruptcy was declared, 76.1% were limited liability companies (compared to 74.2% in the second quarter of 2023) and 9.8% were limited partnerships (compared to 7.2% in the second quarter of 2023).

The data presented in this study are prepared in accordance with the guidelines developed by Eurostat and include information on registration and bankruptcy of enterprises (defined as a single legal unit) with a predominant type of activity classified as, according to NACE Rev. 2, sections from B (mining and quarrying) to S (other service activities), excluding section O (public administration and defence; compulsory social security) and division 94 (activities of membership organisations).

By legal form, the data include the: civil partnerships operating based on a contract concluded in accordance with the Civil Code, natural persons conducting economic activity, professional partnerships, public limited companies, simple joint stock companies, limited liability companies, general partnerships, limited partnerships, public limited partnerships, state enterprises, cooperatives, branches of foreign enterprises, companies provided for in provisions other than the Commercial Companies Code and the Civil Code or legal forms to which the provisions on companies apply, foreign enterprises, entities with no specific legal form.

In the study, there are additional forms of grouping introduced apart from the generally classification:

- "industry" including sections: mining and quarrying (section B), manufacturing (section C), electricity, gas steam and air conditioning supply (section D), water supply; sewerage, waste management and remediation activities (section E);
- "services" including sections: financial and insurance activities (section K), real estate services (section L), professional, scientific and technical activities (section M), administrative and support service activities (section N);

 "other sections" including sections: education (section P), human health and social work activities (section Q), arts, entertainment and recreation (section R), other service activities (section S excluding division 94 activities of membership organisations).

The number of bankruptcies in a given quarter applies to enterprises against which a decision on declaration of bankruptcy has been issued by a competent District Court in a given quarter.

The number of registrations in a given quarter applies to enterprises that were registered in the National Official Registry of Entities of the National Economy (REGON) in a given quarter. The registrations also include natural persons that terminated than restarted economic activity.
