

Information on entities of the national economy entered in the REGON register - May 2022

An increase in the number of newly registered entities in relation to the previous month

As at the end of May 2022 the REGON register included 4 886.5 thous. of national economy entities, i.e. by 0.3% more than a month before (3.3% more than in the corresponding period of the previous year).

Newly registered entities in the REGON register

An increase in the number of newly registered entities was recorded for companies (by 4.9%), including limited liability companies (by 4.0%) compared to the previous month. The number of newly registered natural persons conducting economic activity increased by 4.3% in relation to the previous month.

An increase in the number of newly registered civil partnerships by 15.5% in relation to the previous month

Deregistered entities from the REGON register

In May, 15.6% less entities were deregistered from the REGON register in relation the previous month. A decrease in the number of deregistered entities was recorded for civil partnerships (by 11.8%), for commercial companies, on the other hand, there was an increase in the number of deregistered entities (by 2.9%), including limited liability companies (by 7.7%) compared to the previous month.

A decrease in the number of deregistered natural persons conducting economic activity by 17.5% in relation to the previous month

Entities with suspended activity in the REGON register

Entities with suspended activity as at the end of May 2022 accounted for 12.3% of the total number of registered entities in the REGON register. A decrease in the number of entities with suspended activity was noted in section of real estate activities (by 1.5%) end education (by 1.5%), financial and insurance activities (by 1.3%), information and communication (by 1.2%).

A decrease in the number of entities with suspended activity by 0.3% in relation to the previous month

Chart 1. The number of newly registered entities entered in the REGON register

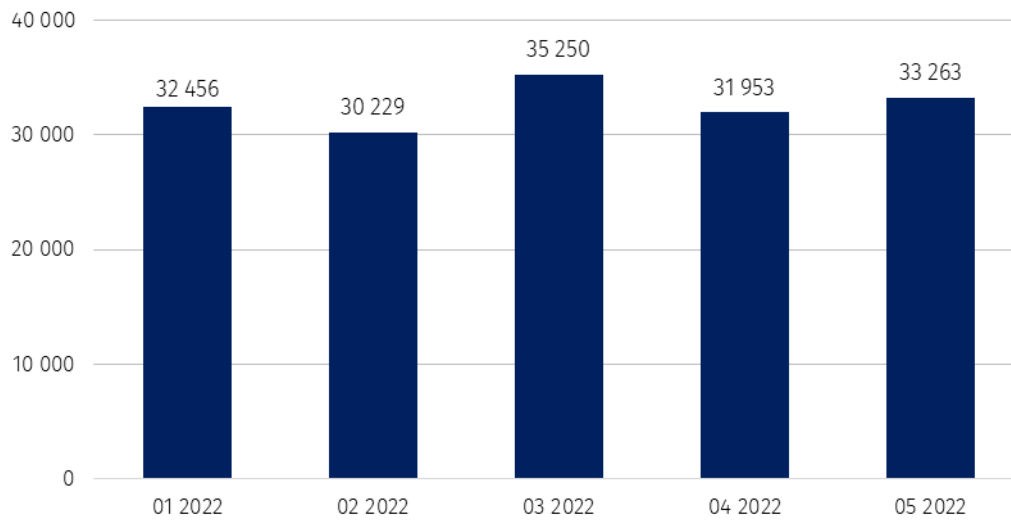


Chart 2. The number of newly registered and deregistered entities in the REGON register by PKD sections

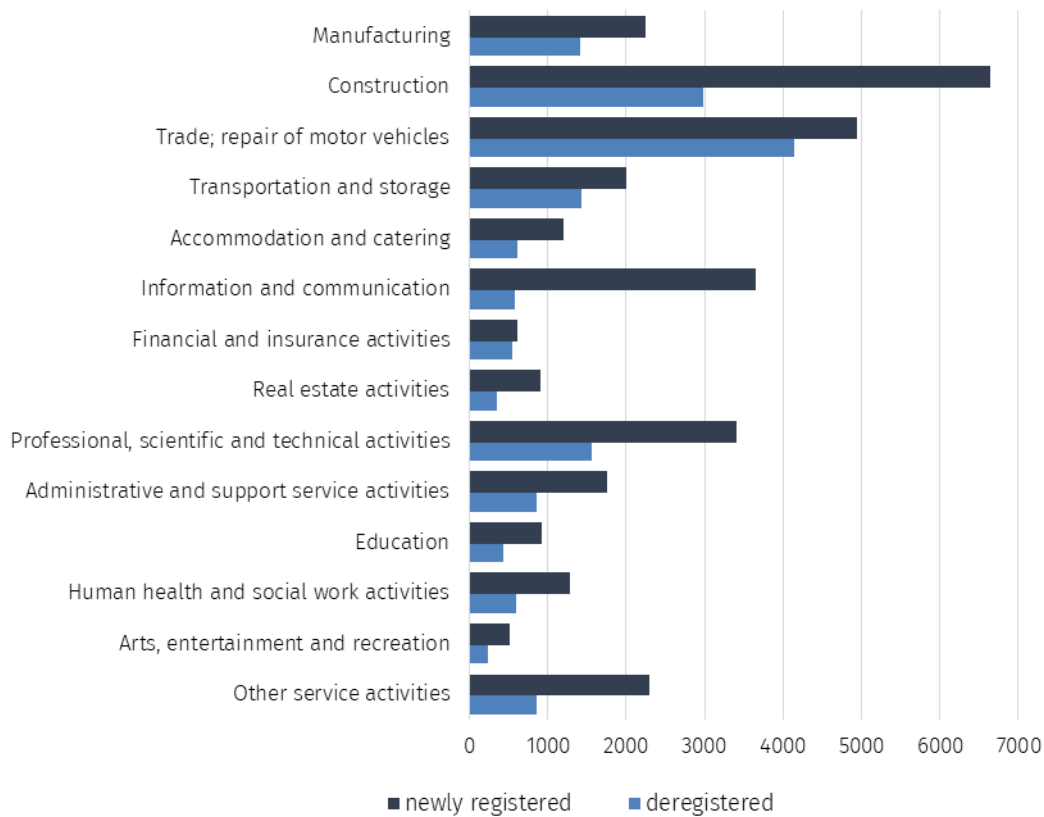
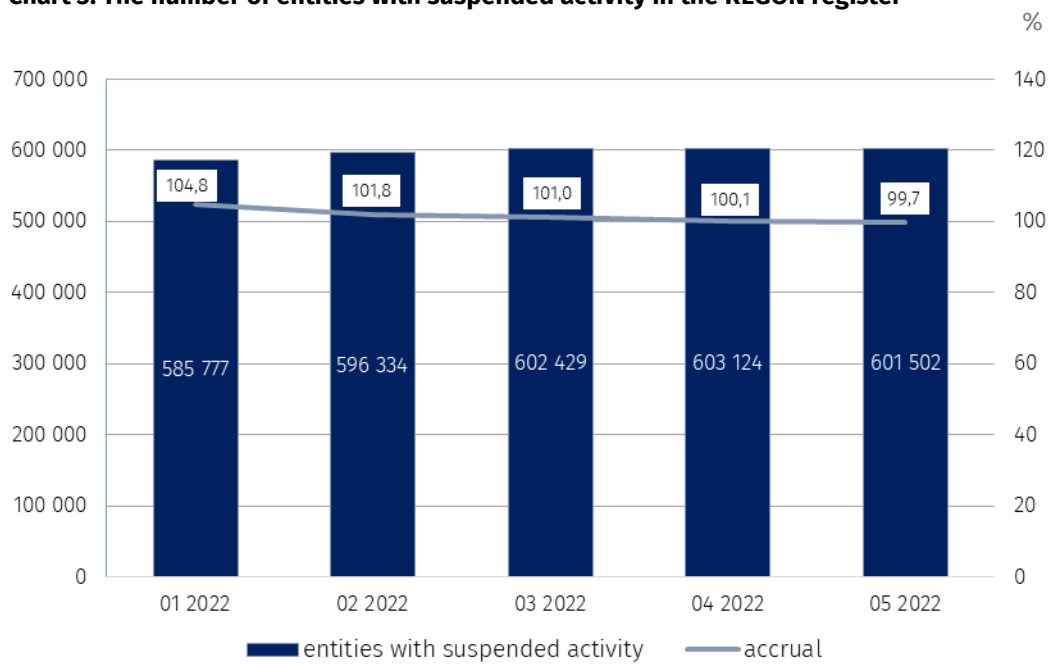


Chart 3. The number of entities with suspended activity in the REGON register
