REGULATION

OF THE COUNCIL OF MINISTERS

of 24 June, 2020

amending the Regulation on the Polish Classification of Activities (PKD)

Pursuant to Article 40 (2) of the Law of 29 June 1995 on Public Statistics (JL of 2020, item 443) the following is hereby ordained:

- § 1. In the Regulation of the Council of Ministers of 24 December 2007 on the Polish Classification of Activities (PKD) (JL item 1885, JL of 2009, item 489 and of 2017, item 2440) the Annex is amended as follows:
- 1) in part 2 Classification scheme, section R Arts, entertainment and recreation, division 93 Sports activities and amusement and recreation activities, group 93.2 Amusement and recreation activities, class 93.29 Other amusement and recreation activities is replaced by the following:

93.29		Other amusement and recreation activities

- 2) in part 3 Explanatory notes to PKD 2007
 - a) in section H Transportation and storage, division 52 Warehousing and support activities for transportation:
 - the description of subclass 52.22.A Service activities incidental to sea transportation paragraph two, indent three is replaced by the following:
 - "- operation of marinas, classified under 93.29.B",
 - the description of subclass 52.22B Service activities incidental to inland transportation paragraph two, indent two is replaced by the following:
 - "- operation of marinas, classified under 93.29.B",
 - b) in section I Accommodation and food service activities, division 56 Food and beverage service activities, the description of subclass 56.30.Z Beverage serving activities, paragraph three, indent three is replaced by the following:
 - "- operation of discotheques and dance floors without beverage serving, classified under 93.29.A".

"93.29 Other amusement and recreation activities

93.29.A Operation of mystery rooms, horror houses, dance floors, and other forms of amusement and recreation held indoors or in other premises with enclosed spaces

This subclass includes:

- activities of escape rooms,
- activities of horror houses,
- activities of dance floors (e.g. discotheques, dance halls),
- organisation of various amusement and recreation activities such as games, shows themed exhibitions and other events indoors or in other places with enclosed spaces,
- activities of producers and sponsors of live performances, other than artistic or sporting ones, held indoors or in other places with enclosed spaces.

This subclass excludes:

- beverage serving by discotheques, classified under 56.30.Z,
- theatre, opera, ballet, musical and other activities, classified under 90.01.Z,
- activities of circus groups, orchestras, music bands, classified under 90.01.Z,
- activities of individual artists such as actors, dancers, musicians, lecturers or speakers, classified under 90.01.Z,
- organisation of various amusement and recreation activities such as games, shows, themed exhibitions and other events held outdoors or in other premises with open spaces, classified under 93.29.B,
- activities of producers and sponsors of live performances, other than artistic or sporting ones, held outdoors or in other premises with open spaces, classified under 93.29.B

93.29.B Other amusement and recreation activities, n.e.c.

This subclass includes other amusement and recreation activities, n.e.c. (excluding amusement parks and theme parks) such as:

- exploitation of machines for games of skill, including coin-operated games,
- activities of recreation parks (without accommodation),
- recreational transport facilities, e.g. operation of marinas,
- operation of ski hills,
- renting of leisure and pleasure equipment as an integral part of recreational facilities,
- fairs and shows of a recreational nature,

- operation of beaches, including renting of facilities, such as bathhouses, lockers, chairs, etc.,
- organisation of various amusement and recreation activities such as games, shows, themed exhibitions and other events held outdoors or in other premises with open spaces,
- activities of producers and sponsors of live performances, other than artistic or sporting ones, held outdoors or in other premises with open spaces.

This subclass excludes:

- activities of dance floors (e.g. discotheques, dance halls), classified under 93.29.A,
- activities related to the operation of teleferics, funiculars, ski and cable lifts, classified under 49.39.Z,
- fishing cruises, classified under 50.10.Z, 50.30.Z,
- renting of short-term accommodation and camping grounds to forest and recreational parks visitors, classified under 55.30.Z,
- activities of camping grounds, recreational camps and fishing and hunting camps, classified under 55.30.Z,
- theatre, opera, ballet, musical and other activities, classified under 90.01.Z,
- activities of circus groups, orchestras, music bands, classified under 90.01.Z,
- activities of individual artists such as actors, dancers, musicians, lecturers or speakers, classified under 90.01.Z";

§ 2. 1. With respect to applications for entry of entities:

- 1) starting an economic activity,
- 2) running an economic activity the subject of which is identified by the PKD code 93.29.Z, and which after the entry into force of this Regulation have applied for amendment to the entry in the Central Registration and Information on Business (Centralna Ewidencja i Informacja o Działalności Gospodarczej), National Court Register (Krajowy Rejestr Sądowy) or National Official Business Register (Krajowy Rejestr Urzędowy Podmiotów Gospodarki Narodowej)
 - the provisions of the Regulation referred to in § 1, as amended by this Regulation shall apply.
 - 2. With respect to entities which, in the entry referred to in § 1 (2) as a designation of the scope of their economic activity have the PKD code number 93.29.Z, and which after the entry into force of this Regulation, have not applied for amendment to the entry in the Central Registration and Information on Business (Centralna Ewidencja i Informacja o Działalności Gospodarczej), National Court Register (Krajowy Rejestr Sądowy) or National Official Business Register (Krajowy Rejestr Urzędowy Podmiotów Gospodarki Narodowej) the provisions of the Regulation referred to in § 1 shall apply in their current wording, for no longer than 12 months.
 - § 3. The Regulation shall enter into force on 1 August 2020.
