Announcement of the President of Statistics Poland of 18 February 2021

on the average monthly wage and salary in the national economy in 2020 and in the second half of 2020

Pursuant to Article 5(7) of the Act of 4 March 1994 on the Employee Benefit Fund (Journal of Laws 2020, item 1070 and 2400) and in connection with Article 110(5)(1) of the Act of 13 October 1998 on the Social Insurance System (Journal of Laws 2020, item 266 as amended[1]) it is announced that the average monthly wage and salary in the national economy less contributions for retirement pension insurance, disability insurance and sickness insurance deducted from earnings of the persons insured in 2020 amounted to PLN 4 512.41, and in the second half of 2020 amounted to PLN 4 651.78.
