Financial results of banks in 2021

In 2021 the net financial result of the banking sector[1] amounted to 8.9 bn PLN, in comparison with minus 0,3 bn PLN in 2020. The balance sheet total increased by 9.3% y/y and amounted to 2 556.7 bn PLN. The value of loans for the non-financial sector increased by 4.6% y/y to 1 186.4 bn PLN, while the value of deposits of this sector increased by 7.9% y/y to 1 537.0 bn PLN.

Price indices of residential premises in the fourth quarter of 2021

Prices of residential premises in the fourth guarter of 2021, compared to the third guarter of 2021, increased by 3.9% (of which on the primary market - by 4.2% and on the secondary market - by 3.7%). Compared to the corresponding quarter of 2020, prices of residential premises increased by 12.1% (of which on the primary market - by 11.9% and on the secondary market - by 12.2%).

Foreign trade turnover of goods in total and by countries in January-February 2022

Foreign trade turnover in January - February 2022 in exports at current prices amounted to PLN 226.6 bn, while in imports - PLN 240,8 bn. The negative balance reached the level of PLN 14.2 bn, while in the same period of 2021 year was positive and amounted to PLN 7.8 bn. In comparison to the corresponding period of 2021 exports increased by 18.6%, while imports by 31.4%.
