

Consumer tendency – January 2023

19.01.2023



In January 2023, there was an improvement in both current and future consumer sentiment moods compared to the previous month. The current consumer confidence indicator, synthetically describing the current trends in individual consumption, was -38.1° which was by 3.8 p.p. higher in relation to last month.

Current consumer confidence indicator in January 2023

All components of the indicator obtained values higher than a month ago. The largest increases were recorded in evaluations of the future economic situation of the country, and current economic situation of the country (increases by 5.1 and 4.2 percentage points, respectively). For the other components of the indicator, the increases were as follows: by 4.1 percentage points in the evaluation of the future financial situation of a household by 3.3 percentage points in the evaluation of the current possibility of making important purchases and by 2.3 percentage points in the evaluation of the current financial situation of a household.

Referring to January 2022, the current value of current consumer confidence indicator is lower by 8.9 percentage points.

Leading consumer confidence indicator in January 2023

The leading consumer confidence indicator, synthetically describing trends in individual consumption that are expected in the coming months, increased by 3.1 percentage points in relation to the previous month, and was at the level of -27.6°.

The increase in the value of the indicator was most influenced by the evaluations of the future economic situation of the country and future level of unemployment (increases by 5.1 and 4.5 percentage points, respectively). There was also an increase in the evaluation of the future financial situation of a household (by 4.1 percentage points). A lower value than a month before was recorded only for the evaluation of the possibility of future money saving (decrease by 1.4 percentage points).

In January this year leading consumer confidence indicator reached a value lower by 4.1 percentage points than in the corresponding month of 2022.

Answers to additional questions in connection with the current situation on the territory of Ukraine are presented in the annex.

Leading consumer confidence indicator increased by 3.1 percentage points compared to the previous month

Current consumer confidence indicator is higher by 3.8 percentage points compared to the previous month

^a Both consumer confidence indicators receive values between -100 and +100. A positive value means dominance of consumers with optimistic attitude over consumers with pessimistic attitude, while negative value means dominance of consumers with pessimistic attitude over consumers with optimistic attitude. In the period of 02-12.01.2023, 1611 interviews were conducted.

Chart 1. Current consumer confidence indicator and its component values by month in 2020-2023




Chart 2. Current consumer confidence indicator and its component values by years



Chart 3. Leading consumer confidence indicator and its component values by month in 2020–2023





Chart 4. Leading consumer confidence indicator and its component values by years

Additional questions in relation to the current situation on the territory of Ukraine




respondents declared the impact of the current situation on the territory of Ukraine on responses regarding the consumer tendency (in December it was 72.1%)


In January 2023, for 26.5% of respondents, the current situation on the territory of Ukraine poses a big threat for the sovereignty and independence of Poland (decrease of 3.7 percentage points compared to the previous month).

Impact of the current situation on the territory of Ukraine on responses to the consumer tendency

From among respondents declaring the impact of the current situation on the territory of Ukraine on responses regarding the consumer tendency, 46.5% described it as moderate and 20.1% as significant. For 33.4% of respondents, the current situation had no impact on the answers.

20.1% of respondents declared a significant impact of the current situation on the territory of Ukraine on responses regarding the consumer tendency






Fear of losing a job or stopping running your own business due to the current situation on the territory of Ukraine

Among the employed (60.8% of respondents), 2.7% of respondents have a definite fear of losing their job or stopping their own business. For the "possible" and "rather not" options, the response rate was 8.7% and 27.8%, respectively. The percentage of working people who do not have any concerns is 55.6%. A small number of working respondents (5.2%) had no opinion.

Chart 2. Fear of losing your job or stopping your own business due to the current situation on the territory of Ukraine - structure of responses for employees (%)




What threat is the current situation on the territory of Ukraine for the economy in Poland

According to 31.4% of respondents, the current situation on the territory of Ukraine is a big threat for the economy in Poland. The average threat to the economy is felt by 45.2% of respondents. Only 18.9% declare a small threat, while barely 4.5% of respondents declare no threat.

Chart 3. What is the threat of the current situation on the territory of Ukraine for the economy in Poland - response structure (%)




What threat is the current situation on the territory of Ukraine for personal financial situation

For 9.9% of respondents, the current situation on the territory of Ukraine is a big threat for their personal financial situation. The average threat is felt by 33.6% of those who answered the questions about the consumer tendency. A small threat is declared by 35.1%, while no threat was stated by 21.4% of respondents.

What threat is the current situation on the territory of Ukraine for the sovereignty and independence of Poland

For 26.5% of respondents, the current situation on the territory of Ukraine is a big threat for the sovereignty and independence of Poland. The average threat is felt by 40.1% of those who answered the questions about the consumer tendency. 25.2% declare a small threat, while only 8.2% of respondents declare no threat.

Chart 5. What is the threat of the current situation on the territory of Ukraine for the sovereignty and independence of Poland - response structure (%)


