

Foreign trade turnover of goods in total and by countries in January - September 2021

Foreign trade turnover¹ in January – September 2021 in exports at current prices amounted to PLN 942.9 bn, while in imports – PLN 934.7 bn. The positive balance reached the level of PLN 8.2 bn, while in the same period of 2020 year amounted to PLN 29.9 bn. In comparison to the corresponding period of 2020 exports increased by 24.4%, while imports by 28.4%.

Foreign trade turnover expressed in US dollars and in EUR

Exports expressed in USD amounted to 248.6 bn, while imports amounted to USD 246.4 bn (an increase in exports of 28.8% and in imports of 32.8%). The positive balance reached the level of USD 2.2 bn, while in the same period of 2020 year amounted to USD 7.5 bn.

Exports expressed in EUR amounted to 207.4 bn, while imports amounted to EUR 205.6 bn (an increase in exports of 20.3% and in imports of 24.1%). The positive balance reached EUR 1.8 bn, while EUR 6.7 bn in the same period of 2020.

Foreign trade turnover of goods in total and by groups of countries

Poland has the largest share in total exports with the developed countries – 86.3% (of which EU 74.8%) and in imports – 63.4% (of which EU 54.8%), in comparison with 86.4% (of which EU 73.9%) and 65.3% (of which EU 55.5%) in the corresponding period in 2020 year. However, the smallest share was observed with the countries of Central and Eastern Europe, which in total exports amounted to 5.7%, and in imports – 7.6%, in comparison with 6.0% and 6.3% in the January – September 2020 period.

The negative balance was recorded with the developing countries – minus PLN 195.1 bn (minus USD 51.4 bn, minus EUR 42.9 bn) and with the countries of Central and Eastern Europe minus PLN 17.8 bn (minus USD 4.7 bn, minus EUR 3.9 bn). The positive balance was obtained in turnover with the developed countries PLN 221.2 bn (USD 58.3 bn, EUR 48.6 bn), of which with the EU countries the balance of PLN 193.0 bn (USD 50.9 bn, EUR 42.4 bn).

Note. Due to the rounding of data, in some cases sums of components may slightly differ from the amount given in the item "total".

Foreign trade turnover by major countries

After three quarters this year among the main trade partners of Poland a decrease both in exports and imports was not observed compared to the same period of the last year.

The turnover with the top ten of Polish trade partners in exports accounted for 65.1% (65.8% in the same period of the last year), while in total imports – 64.6% (in comparison with 64.2% in January – September 2020).

The share of Germany in exports was at the same level in comparison with the corresponding period of the last year and amounted to 28.7% and in imports decreased by 0.6 pp and accounted for 21.2%. The positive balance amounted to PLN 72.7 bn (USD 19.1 bn, EUR 16.0 bn) in comparison with PLN 58.6 bn (USD 14.9 bn, EUR 13.3 bn) in the same period of 2020.

² Country of origin is the country where the commodity was produced or processed and in this form entered the Polish customs zone.

Imports by country of consignment – total and groups of counties

The highest turnover in imports by country of consignment Poland recorded with the developed countries - PLN 674.8 bn, of which with the EU – PLN 623.9 bn, compared to PLN 542.5 bn, of which with the EU - PLN 492.5 bn in the same period of 2020.

Imports by country of consignment – countries

The share of Germany in imports by country of consignment in comparison with imports by country of origin was higher by 5.3 pp, accordingly the share of the Netherlands was higher by 2.3 pp, Belgium by 1.3 pp, Czechia by 0.6 pp and France by 0.4 pp.

³ Country of consignment is the country from which the goods were introduced into the Polish territory irrespective of their origin.

After nine months of 2021 trade turnover in goods according to the SITC nomenclature compared to the same period of 2020 year, reported an increase in all commodity sections both in exports and imports.

In exports the largest increase concerned mineral fuels, lubricants and related materials (by 49.6%), animal and vegetable oils, fats and waxes (by 43.2%), crude materials inedible, except fuels (by 36.7%), manufactured goods classified chiefly by material (by 28.6%), machinery and transport equipment (by 26.8%), miscellaneous manufactured articles (by 23.9%), chemicals and related products (by 22.5%), food and live animals (by 12.1%), commodities and transaction not classified elsewhere in the SITC (by 7.7%) and beverages and tobacco (by 0.7%).

In imports an increase was recorded in commodities and transaction not classified elsewhere in the SITC (by 131.7%), manufactured goods classified chiefly by material (by 38.9%), mineral fuels, lubricants and related materials (by 38.2%), crude materials inedible, except fuels (by 37.5%), chemicals and related products (by 29.8%), animal and vegetable oils, fats and waxes (by 29.4%), machinery and transport equipment (by 25.7%), miscellaneous manufactured articles (by 22.4%), food and live animals (by 7.7%) and beverages and tobacco (by 4.7%).

Chart 1. Composition of exports by sections according to SITC nomenclature in I - IX 2021





Chart 2. Composition of imports by sections according to SITC nomenclature in I - IX 2021
