Foreign trade turnover¹ in the first quarter of this year according to exports at current prices amounted to PLN 218.8 bn, while imports amounted to PLN 222.8 bn. The negative balance reached the level of PLN 4.0 bn, while the same period last year was positive and amounted to PLN 2.9 bn. In comparison to the corresponding period of the 2017, exports decreased by 0.8%, and imports increased by 2.3%.

In the first quarter, there was a decline in exports to the corresponding period of the previous year

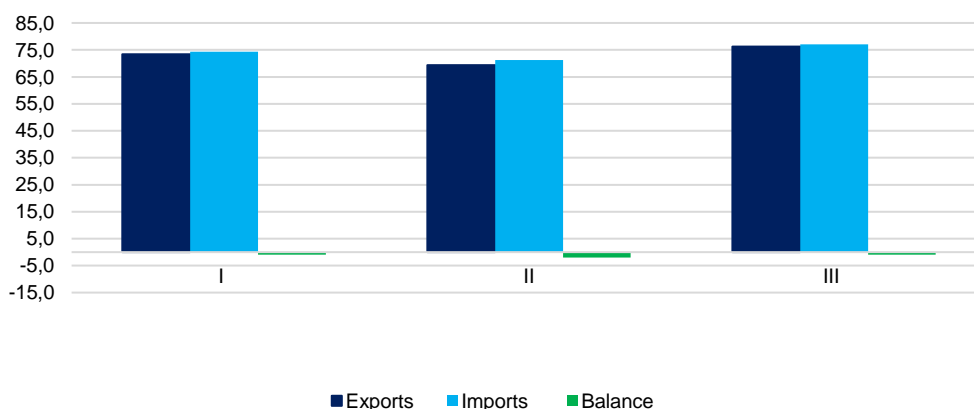
Foreign trade turnover expressed in US dollars and in EUR

Exports expressed in USD amounted to 63.8 bn USD while imports amounted to USD 65.0 bn (an increase in exports of 19.6% and in imports of 23.3%). The negative balance reached the level of USD 1.2 bn (in the corresponding period of the 2017, the positive balance amounted to USD 0.7 bn).

For the third consecutive month, there was a negative balance in foreign trade

Exports expressed in EUR amounted to 52.5 bn while imports amounted to EUR 53.4 bn (an increase in exports of 3.7% and in imports of 6.9%). The negative balance reached the level of EUR 0.9 bn compared to positive balance EUR 0.7 bn in the same period in 2017.

Foreign trade turnover of goods in total and by groups of countries

Poland has the largest share in total exports with developed countries - 87.1% (of which EU 80.4), and imports – 66.2% (of which EU 59.1%), as against 87.2% (of which EU 80.4%) and 67.4% (of which EU 60.2%) in the corresponding period of the previous year. However, the smallest share was observed in the countries of Central and Eastern Europe, which in total

exports amounted to 5.5%, and in imports – 8.9%, as against 5.3% and 8.0% in January – March 2017.

The negative balances were recorded with developing countries – minus PLN 39.3 bn (minus USD 11.4 bn, minus EUR 9.4 bn) and with countries Central and Eastern Europe – minus PLN 7.8 bn (minus USD 2.3 bn, minus EUR 1.8 bn). The positive balances were obtained in turnover with developed countries PLN 43.1 bn (USD 12.5 bn, EUR 10.3 bn), of which EU countries a balance of PLN 44.4 bn (USD 12.9 bn, EUR 10.6 bn).

Foreign trade turnover by major countries

In the first quarter this year among the main trade partners of Poland there was an increase in exports to the United States, Russia, Sweden and Germany and imports – from the United States, Russia, Spain, France, Germany and Netherlands.

The turnover with the top ten of Polish trade partners in exports as in the corresponding period of the previous year – 66.7%, while total imports – 65.7% (against 66.0% after three months 2017) .

Among our main trade partners in exports we recorded a decreased in turnover for the six countries, compared to four in January – February 2018

² Country of origin is the country where the commodity was produced or processed and in this form entered the Polish customs zone.

The share of Germany in exports increased in comparison with the corresponding period of last year by 0.3 pp and amounted to 27.8%, and imports has decreased by 0.2 pp and accounted for 22.6%. The positive balance amounted to PLN 10.5 bn (USD 3.0 bn, EUR 2.5 bn) against PLN 11.2 bn (USD 2.7 bn, EUR 2.6 bn) in the same period of 2017.

Imports by country of consignment in total and by groups of counties

The highest turnover in imports by country of consignment Poland recorded with the developed countries - PLN 165.6 bn, of which the EU – PLN 155.4 bn, compared to PLN 165.6 bn, of which the EU - PLN 155,4 bn in the same period of 2017.

Imports by country of consignment – by countries

The share of Germany in imports by country of consignment to imports by country of origin was higher by 4.4 pp, accordingly the share of the Netherlands was higher by 1.9 pp, Belgium by 1.2 pp, Czech Republic by 0.5 pp and Russia by 0.4 pp.
