

Domestic deliveries and consumption of selected consumer goods per capita in 2021

An increase in a meat deliveries to the domestic market compered to 2020

In 2021 domestic deliveries¹ of meat (including pork, beef, veal and poultry meat) amounted to 4348 thousand tons and were higher by 3.7% compared to the previous year.

The deliveries of both raw meat from animals for slaughter (by 5.4%) and poultry meat (by 1.3%) increased

The domestic market supply of selected food goods

In 2021 the deliveries of a frozen sea fish; chocolate (including chocolates, chocolate products and white chocolate); vodkas, liqueurs, other spirit beverages of which pure vodka were much higher than in the previous year. The significant increase in deliveries was reported also for the following foodstuffs: raw meat from animals for slaughter; meat and variety meat products from animals for slaughter; wine and mead of which grape wine (including vermouth). In comparison with 2020, the deliveries of variety meat products from poultry; margarine and reduced and low fat spreads; rye flour were much smaller however.

In 2021 deliveries of the majority of presented foodstuffs were higher than in 2020
