Index of value of sold production of own products by producers

The value of sold production of own products by producers in 2017 increased in relation to the previous year by 9.2% and amounted to 1 115 410 342 thousand zl.


Sold production of industrial products

The total value of sold production of own products by producers, classified to the sections: Products of mining and quarrying and Manufactured products, amounted to 1 115 410 342 thousand PLN and was higher than in the previous year by 9.2%.

The following divisions had the largest share in the total value of sold production of products: Food products – 17.0%, Motor vehicles, trailers and semi-trailers – 11.9%, Coke, briquette and similar solid fuels from coal and peat, refined petroleum products – 7.9%, Basic metals – 6.3%, Fabricated metal products, except machinery and equipment – 6.1%. The lowest was the share in the total value of sold production of the divisions: Wearing apparel, leather and related products, Metal ores and Crude petroleum and natural gas – each lower than 0.5%.

Food products had the largest share in the value of sold production of products (17.0%)

In relation to the previous year, an increase in the value of sold production was recorded in 26 (out of 28) divisions, among others for Basic metals (by 22.2%), Fabricated metal products, except machinery and equipment (by 18.4%), Coke, briquette and similar solid fuels from coal and peat, refined petroleum products (by 15.8%), Wearing apparel (by 15.6%), Other

transport equipment (by 14.9%), Other products of mining and quarrying (by 13.5%), Hard coal and lignite (by 13.0%). Decrease in the value of sold production of products in comparison to 2016 occurred in the divisions: Crude petroleum and natural gas, and Metal ores.

The following were among the products with largest value of sold production: passenger cars with spark ignition engines of cylinder capacity not exceeding than 1500 cm³; television receivers; upholstered seats with wooden frames; vehicle compression-ignition internal combustion piston engines (excluding for railway or tramway rolling stock); goods vehicles with a compression ignition engine, of a gross vehicle weight not exceeding 5 tonnes; cartons, boxes and cases, of corrugated paper or paperboard; beer from malt; sausages and similar products of meat, offal or blood; cloth washing and drying machines, of the household type;

fresh or chilled cuts of chicken; preparations used for farm animal feeding (excluding premixtures): poultry; fresh bread containing by weight in the dry matter state not more than 5 % of sugars and not more than 5 % of fat; fresh or chilled pig meat; plastic doors and windows; copper wire.

Out of 4377 products and assortment groups of products covered by observation in physical units of measure according to the PRODPOL nomenclature, entities of the national economy reported sold production for 3575 headings. Increase in sold production was noted in 2040 products, among others in: frozen carcases and half-carcases of pig meat (by 322.6%), oleum (by 302.0%), methanol (by 79.7%), chlorine (by 63.8%), fresh or chilled cuts of veal (by 51.1%), sunflower-seed oil packaged (by 40.4%), rails of iron or steel for railway track (by 24.6%), hot rolled products (by 13.0%).

Decrease in production was noted for 1502 products including, among others: machines for working wire (excluding draw-benches, thread rolling machines) (by 71%), vermouth and other wine of fresh grapes flavoured with plants or aromatic substances (by 65.7%), soups and broths and preparations therefor (by 52.7%), margarine (by 45.6%), technical hydrochloric acid (by 25.1%), phosphate fertilizers, mineral or chemical (by 19.9%), aluminium wire (by 10.8%), refined copper (by 5.1%).

Sold production for 33 products remained at the level of the previous year, among others for grape juice, furskins of rabbit, goat or kid skin leather and for prepared rubber accelerators.

Manufactured production of industrial products

Out of 4377 products and assortment groups of products covered by observation in physical units of measure according to the PRODPOL nomenclature, entities of the national economy reported production for 3606 groupings.

Increase in production was noted for 2058 assortment groups of products, among others for: canned vegetables (by 172.2%), casein (by 135.2%), synthetic rubber (by 76.2%), methanol (by 74.8%), potassium fertilizers (by 72.0%), trailers and semi-trailers for transportation of goods, not designed for running on rails (by 51.2%), buckwheat groats (by 45.1%), handbags of leather (by 30.1%), plywood consisting solely of sheets of wood (by 17.4%), tableware and kitchenware of wood (by 16.3%), water meters (by 12.2%), veneer sheets (by 10.3%), domestic electric hobs for building-in (by 9.2%), primary cells and primary batteries (by 7.9%), domestic electric cookers with at least an oven and a hob (including combined gas-electric appliances) (by 2.6%), lignite (by 1.5%).

Decrease in production was noted for 1503 products including, among others, domestic electric hobs for building-in (by 20.0%), epoxide resins (by 28.7%), passenger cars with engines of cylinder capacity exceeding 1500 cm³ (by 18.1%), wheat groats and pellets (by 18.1%), smoked fish (by 15.3%), chocolate with added cereal, fruit or nuts (excl. filled chocolate blocks) (by 11.1%), cases, boxes, crates, drums and similar packings of wood (by 10.3%), electric kettles (by 7.2%), hard coal (by 6.8%), bicycles (by 6.4%).

Production of 25 products remained at the same level as in 2016, among others of salt suitable for human consumption, refined unwrought lead, woven fabrics of silk, bed linen.
