

Residential construction¹ in the period of January-June 2022

In the first half of 2022, there were more dwellings completed than the year before. Whereas the number of dwellings for which permits have been granted or which have been registered with a construction project as well as dwellings in which construction has begun decreased.

Dwellings completed

According to the preliminary data, 109.4 thousand dwellings were completed in the first half of 2022, i.e. 3.8% more than in the previous year. **Developers** completed 62.9 thousand dwellings – by 3.7% more than in 2021, whereas **private investors** completed 44.9 thousand dwellings, i.e. by 6.0% more. Within these forms of construction, 98.5% of the total number of newly completed dwellings was built. Within **other forms** of construction, i.e. cooperative, municipal, public building society and company construction 1 598 dwellings were completed (2 459 in the previous year).

The total useful floor area of dwellings completed amounted to 10.5 million m², i.e. by 4.2% more than a year ago and the average useful floor area of 1 dwelling was 95.5 m².

Dwellings for which permits have been granted or which have been registered with a construction project

In the first half of 2022, permits and registrations have been granted for construction of 170.8 thousand dwellings, i.e. by 0.5% less than in the corresponding period of 2021. Permits for construction of the biggest number of dwellings were given to **developers** (117.5 thousand, an increase of 7.4% y/y) and to **private investors** (50.6 thousand, a decrease of 16.1%). Within these forms of construction, permits have been granted and registrations with a construction project were made for 98.4% of dwellings in total. In **other forms** of construction 2 705 dwellings for which permits have been granted or which have been registered with a construction project were noted (2 015 dwellings in the previous year).

Dwellings in which construction has begun


From the begging of the year till the end of June 2022, the number of dwellings in which construction has begun was 119.7 thousand, i.e. by 17.2% less than a year ago. **Developers** have started construction of 71.6 thousand dwellings (by 18.4% less), and **private** investors of 46.4 thousand (by 14.5% less). Altogether the share of these forms of construction was 98.5% of the total number of dwellings. In **other forms** of construction the number of dwellings in which construction has begun was 1744 (2 605 in the previous year).

The number of dwellings for which permits have been granted or which have been registered with a construction project decreased in the period of 01-06 2022 by 0.5% y/y It is estimated that at the end of June 2022, there were 881.6 thousand dwellings under construction, i.e. by 1.6% more than in the corresponding period of 2021.


Chart 1. Construction activity in the scope of residential construction in Poland



In June, compared to May 2022, the number of dwellings completed increased (by 3.7%), as well as the number of dwellings for which permits have been granted or which have been registered with a construction project (by 15.3%) and the number of dwellings in which construction has begun (by 8.1%)

In the first half of 2022, the highest values of dwellings completed, as well as dwellings in which construction has begun and dwellings for which permits have been granted or which have been registered with a construction project, were recorded in Mazowieckie voivodship (respectively: 18.8 thousand, 21.6 thousand and 31.1 thousand). High values were also noted in Wielkopolskie (12.4 thousand, 11.7 thousand and 16.5 thousand) and Małopolskie (11.1 thousand,11.1 thousand and 14.4 thousand).
