GDP growth in 2020

According to the revised estimate, gross domestic product (GDP) in 2020 decreased by 2.5% to 2019. The result has increased compared to the previously published on 22nd April 2021 by 0.2 percentage points.

Statistics Poland developed a full, revised estimation of gross domestic product (GDP) for 2020 based on annual sources of information and the final estimate for 2019.

The GDP calculated at this time is the basis for estimates of gross national income (GNI) and notification of the deficit and debt of the general government sector (the so-called October EDP notification of 2020).

The presented data on GDP and its components for 2020 have been revised in comparison to the previously published on 22nd April 2021 due to taking into account the more complete annual information on the results for the whole 2020 in the following statistical areas: finance of corporations, foreign trade in goods and services, general government data on deficit and debt developed for October fiscal notification.

The revised estimate of gross domestic product had an impact on the absolute levels and real dynamics of GDP and its components.

The previously presented data on GDP for 2017-2019 remained unchanged.

The table below presents real growth of GDP and its components for 2017-2020.
