General government deficit in 2017 in relation to GDP

According to the EDP notification, in 2017 the general government deficit was equal 27 970 mln zl (1,4% of GDP), while the general government debt amounted to 1 005 688 mln zl (50,6% of GDP).

On 28 September 2018, in accordance with the Council Regulation (EC) No. 479/2009 of 25 May 2009 on the application of the Protocol on the excessive deficit procedure annexed to the Treaty establishing European Community with amendments, the President of the CSO provided the general government deficit and debt data for years 2014-2017 (EDP notification) to the European Commission (Eurostat).

The data have been developed in accordance with the methodology of the European System of National and Regional Accounts in the European Union introduced by the Regulation (EU) No. 549/2013 of the European Parliament and of the Council of 21 May 2013 (ESA2010) and the guidelines contained in the Manual on Government Deficit and Debt, Implementation of ESA2010 (MGDD, 2016 edition)¹.





Graph 2 General government debt in % of GDP




Data for years 2014-2017 have been revised in relation to the previously published (April 2018) due to use of the final source data for 2017 as well as implementation of the European Commission's recommendations after the EDP dialogue visit concerning the reclassification of the next public units into the general government sector and adjustments of accrual data on VAT due to a change in the registration of settlements related to tax refunds (for 2016 and 2017).

Together with the EDP notification, the Statistics Poland sent to the European Commission information about revenues and expenditures of the general government sector divided into transactions, according to the European System of National and Regional Accounts (ESA2010).

Similarly, as in case of deficit and debt, data on general government revenues and expenditures for years 2014-2017 have been revised in relation to the previously published (April 2018).

The revision of general government revenue in years 2014 - 2017 caused their growth respectively of 1,5 bn zl (0,1 percentage points in relation to GDP), 1,3 bn zl (0,1 percentage points in relation to GDP), 2,6 bn zl (0,1 percentage points in relation to GDP) and 5,6 bn zl (no change in relation to GDP). The increase of expenditures in years 2014 - 2017 was observed respectively of 2,6 bn zl (0,1 percentage points in relation to GDP), 2,2 bn zl (0,1 percentage points in relation to GDP), 0,6 bn zl (no change in relation to GDP), 0,6 bn zl (no change in relation to GDP). The revision for years 2014 and 2015 was mainly due to reclassification of public units into the general government sector. For this reason the revenues and expenditures increased, especially the output and gross capital formation. Moreover, in connection with adjustment of accrual data on VAT in 2016 and 2017 taxes in production and imports significantly increased.

Detailed data on revenues and expenditures of the general government sector divided into ESA2010 transactions are presented in Annex 1.
