

Information on entities of the national economy entered in the REGON register - January 2022

The number of newly registered entities in relation to the previous month

As at the end of January 2022 the REGON register included 4 836.3 thous. of national economy entities, i.e. comparatively to the previous month (3.6% more than in the corresponding period of the previous year).

Newly registered entities in the REGON register

The number of newly registered entities increased by 3,3% compared to the previous month. Among newly registered entities, natural persons conducting economic activity accounted for 78.2% of all newly registered entities. The number of newly registered companies has decreased by 12.1%, including commercial companies by 12.3% and civil partnerships by 10.4%.

An increase in the number of newly registered natural persons conducting economic activity by 7.9% in relation to the previous month

Deregistered entities from the REGON register

In January, 46.8% more entities were deregistered from the REGON register than a month ago. 1 198 civil partnerships were deregistered, i.e. 2.3 times more than in the previous month. An increase in the number of deregistered entities was recorded for natural persons conducting economic activity (by 47.6%) and commercial companies (by 9.2%) in compare to the previous month.

An increase in the number of deregistered companies by 52% in relation to the previous month

Entities with suspended activity in the REGON register

Entities with suspended activity as at the end of January 2022 accounted for 12.1% of the total number of registered entities in the REGON register. An increase in the number of entities with suspended activity was noted in section of professional, scientific and technical activities (by 7.0%), real estate activities (by 6.5%), arts, entertainment and recreation activities (by 5.8%).

An increase in the number of entities with suspended activity by 4.8% in relation to the previous month

Chart 1. The number of newly registered entities entered in the REGON register

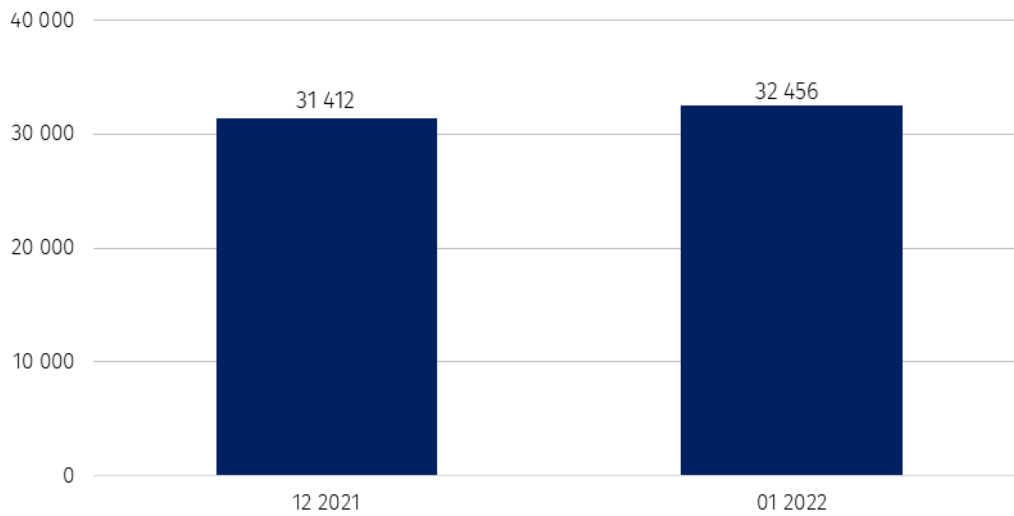


Chart 2. The number of newly registered and deregistered entities in the REGON register by PKD sections

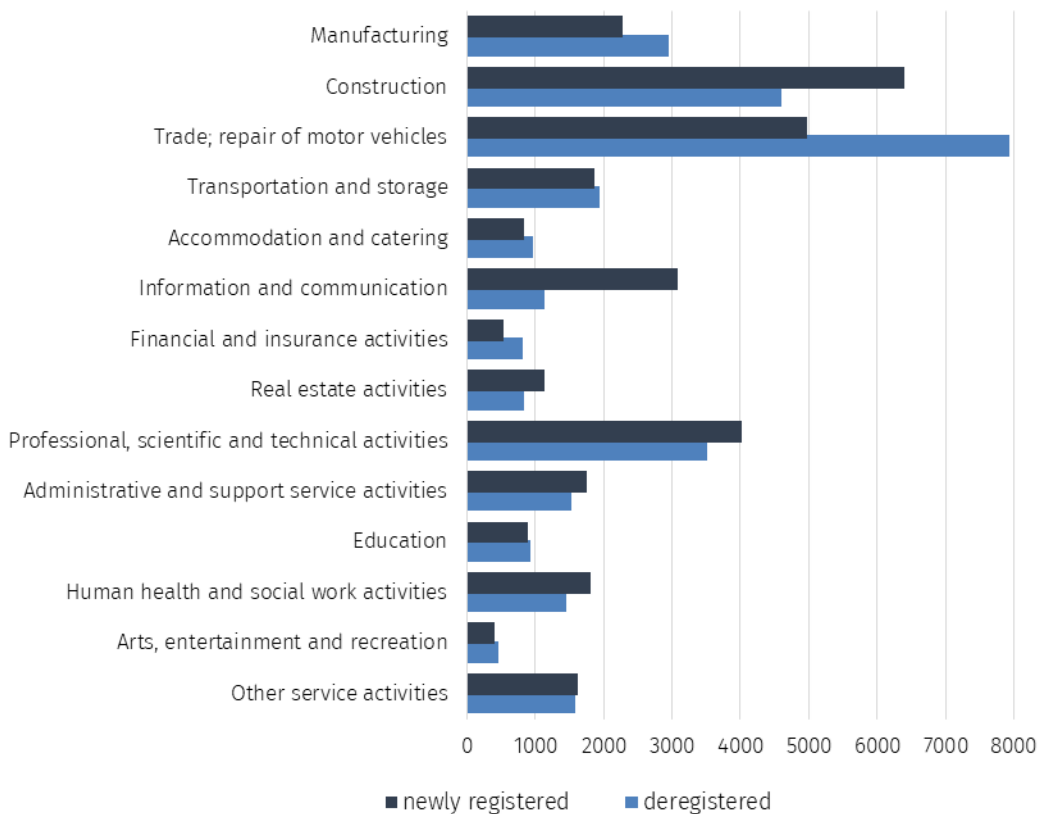
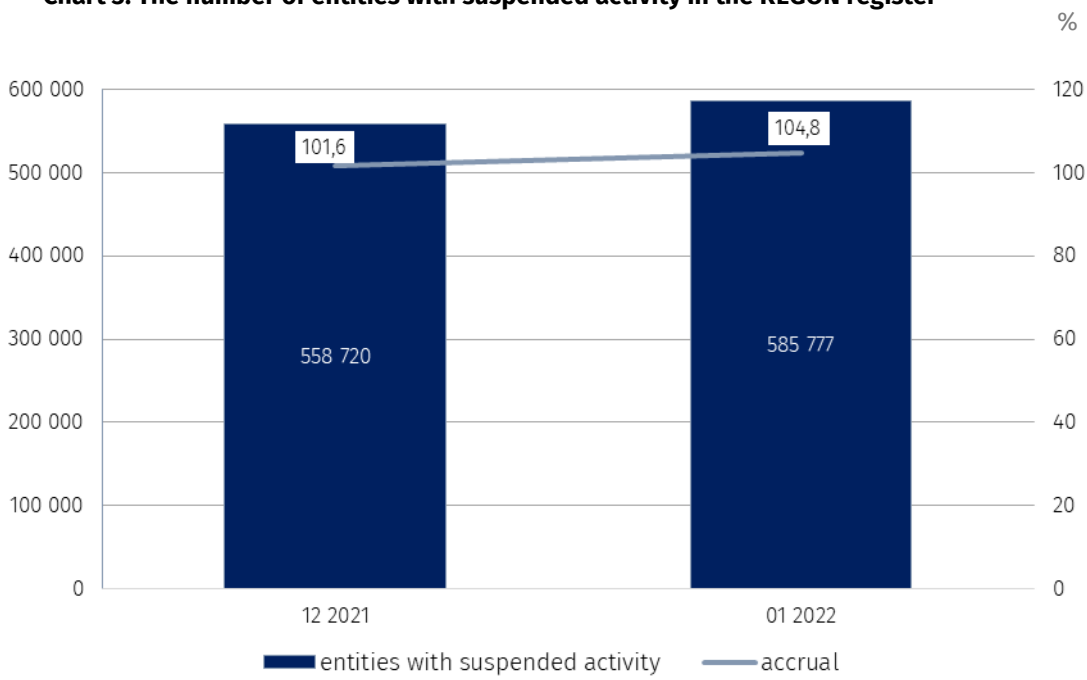


Chart 3. The number of entities with suspended activity in the REGON register
