

Information on entities of the national economy entered in the REGON register - February 2022

The number of newly registered entities in relation to the previous month

As at the end of February 2022 the REGON register included 4 847.3 thous. of national economy entities, i.e. by 0.2% more than a month before (3.6% more than in the corresponding period of the previous year).

Newly registered entities in the REGON register

A decrease in the number of newly registered entities was recorded for civil partnerships (by 14.4%) and natural persons conducting economic activity (by 8.8%). While an increase compared to the previous month was recorded for commercial companies (by 3.3%), including limited liability companies (by 1.6%)

A decrease in the number of newly registered entities by 6.9% in relation to the previous month

Deregistered entities from the REGON register

In February, 39.7% less entities were deregistered from the REGON register than a month ago. A decrease in the number of deregistered entities was recorded for natural persons conducting economic activity (by 41.8%). For commercial companies, an increase in the number of deregistered entities was recorded (by 24.0%) in compare to the previous month.

A decrease in the number of deregistered civil partnerships by 56.4% in relation to the previous month

Entities with suspended activity in the REGON register

Entities with suspended activity as at the end of February 2022 accounted for 12.3% of the total number of registered entities in the REGON register. An increase in the number of entities with suspended activity was noted in section of arts, entertainment and recreation activities (by 3.3%), real estate activities (by 3.1%), other service activities (by 2.6%).

An increase in the number of entities with suspended activity by 1.8% in relation to the previous month

Chart 1. The number of newly registered entities entered in the REGON register

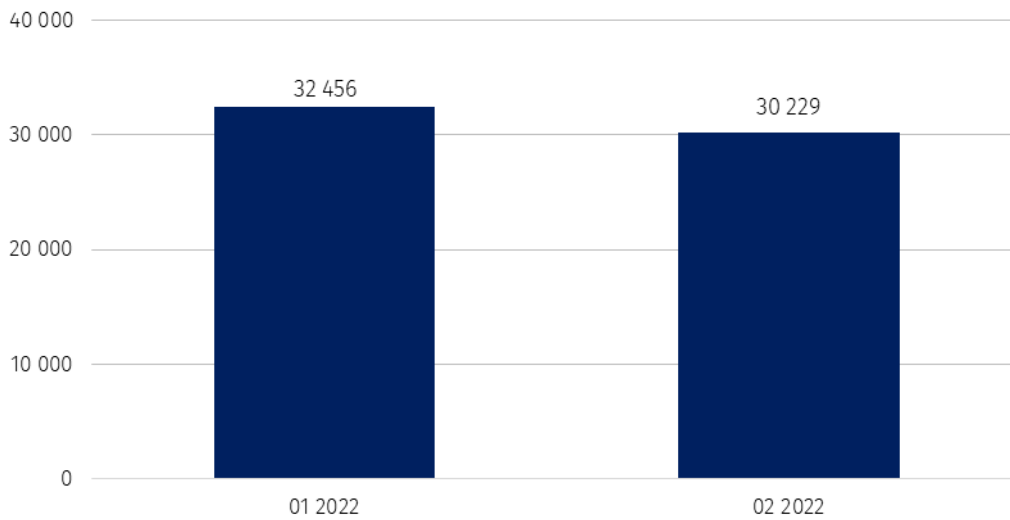


Chart 2. The number of newly registered and deregistered entities in the REGON register by PKD sections

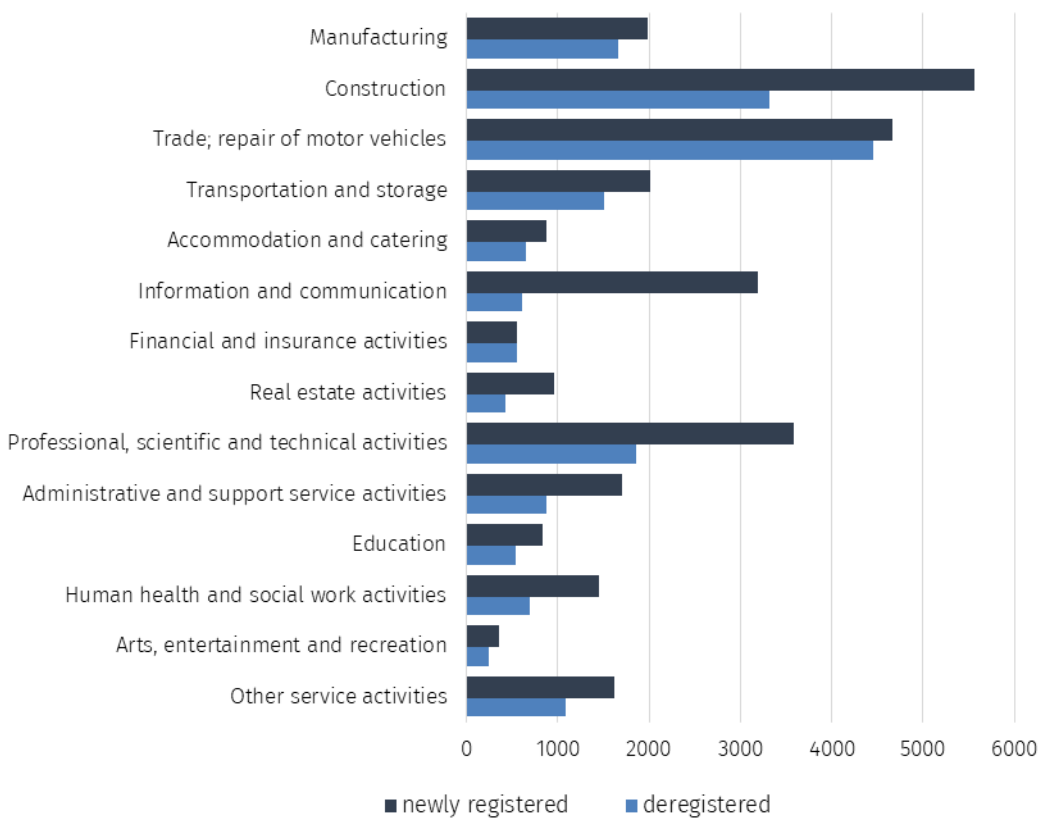
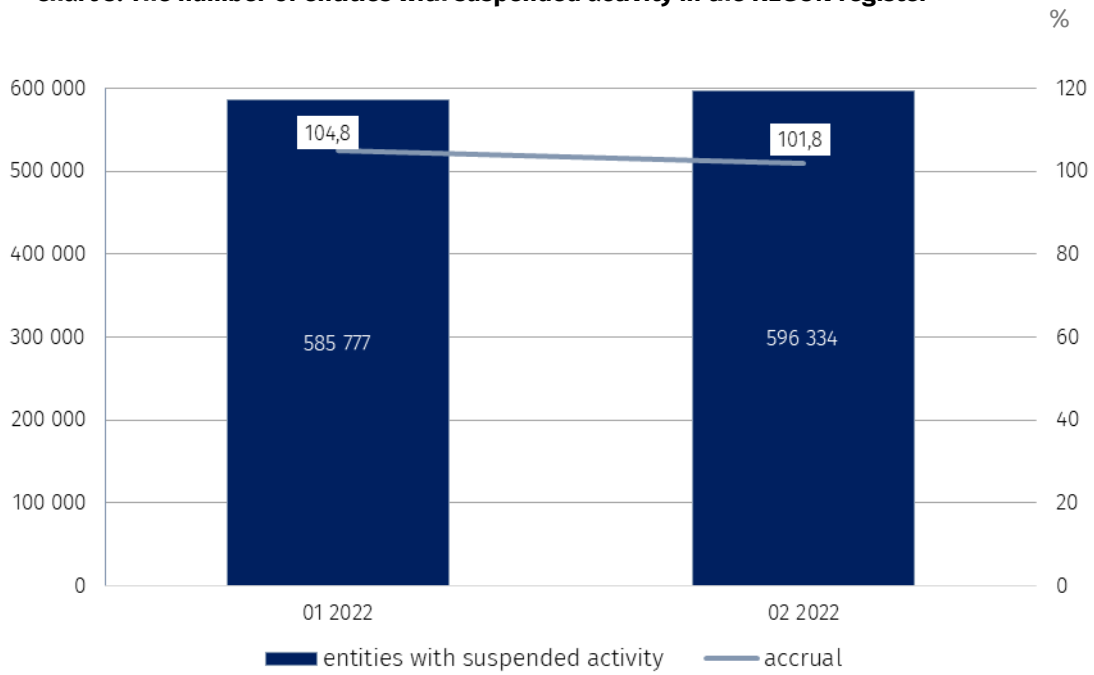


Chart 3. The number of entities with suspended activity in the REGON register
