

# Information on entities of the national economy entered in the REGON register - February 2023

A decrease in the number of newly registered entities in relation to the previous month

**As at the end of February 2023 the REGON register included 5 011.2 thous. of national economy entities, i.e. by 0.2% more than a month before (3.4% more than in the corresponding period of the previous year).**

## Newly registered entities in the REGON register

A decrease in the number of newly registered entities was recorded for natural persons conducting economic activity (by 17.4%) compared to the previous month. Natural persons conducting economic activity accounted for 78.3% of all newly registered entities in the REGON register. On the other hand, an increase was recorded for civil partnerships by 9.7%.

A decrease in the number of newly registered commercial companies by 6.8% in relation to the previous month

## Deregistered entities from the REGON register

In February, 39.4% less entities were deregistered from the REGON register than in the previous month. A decrease in the number of deregistered entities was recorded for natural persons conducting economic activity (by 42.2%) and companies (by 15.5%).

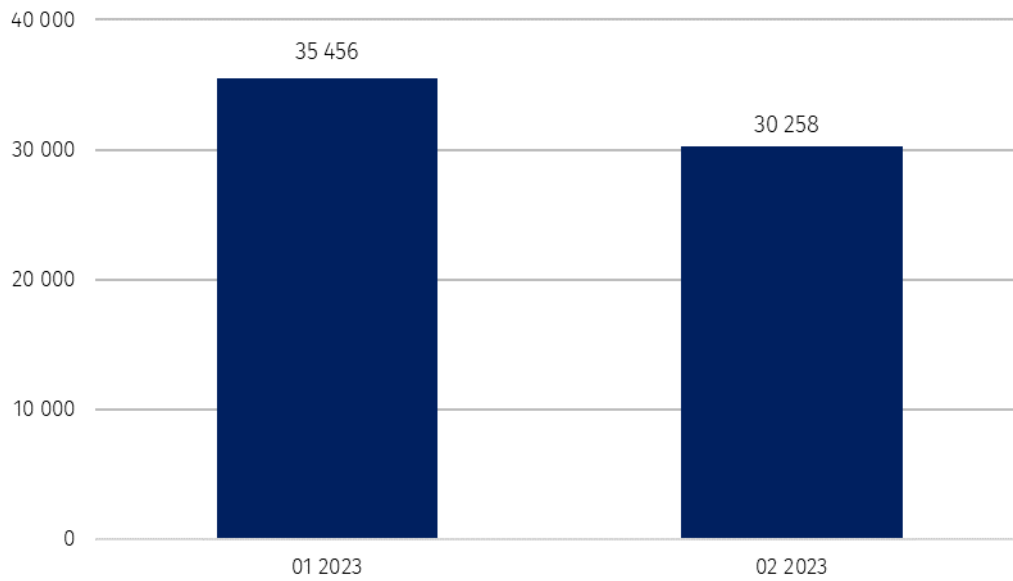
A decrease in the number of deregistered civil partnerships by 55.3% in relation to the previous month

## Entities with suspended activity in the REGON register

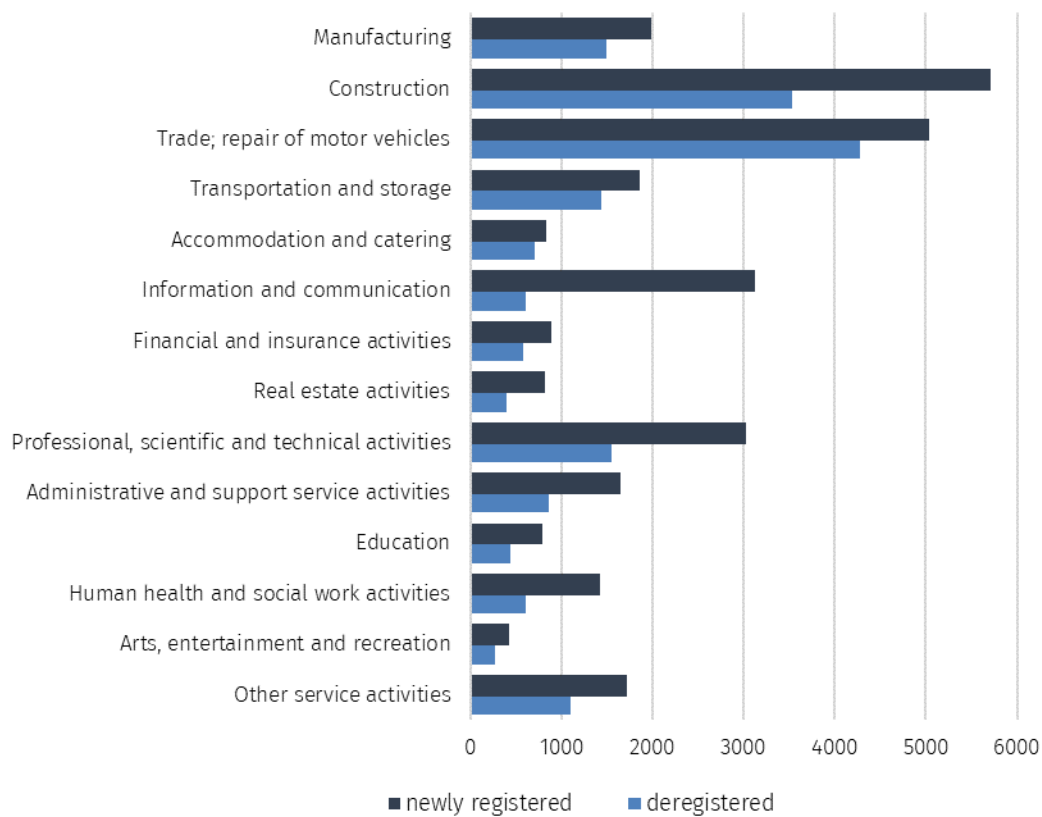
Entities with suspended activity as at the end of February 2023 accounted for 13.7% of the total number of registered entities in the REGON register. The largest increase (by 1.6%) of entities with suspended activity compared to the previous month was recorded in the section information and communication as well as professional, scientific and technical activities.

An increase in the number of entities with suspended activity by 1.1% in relation to the previous month

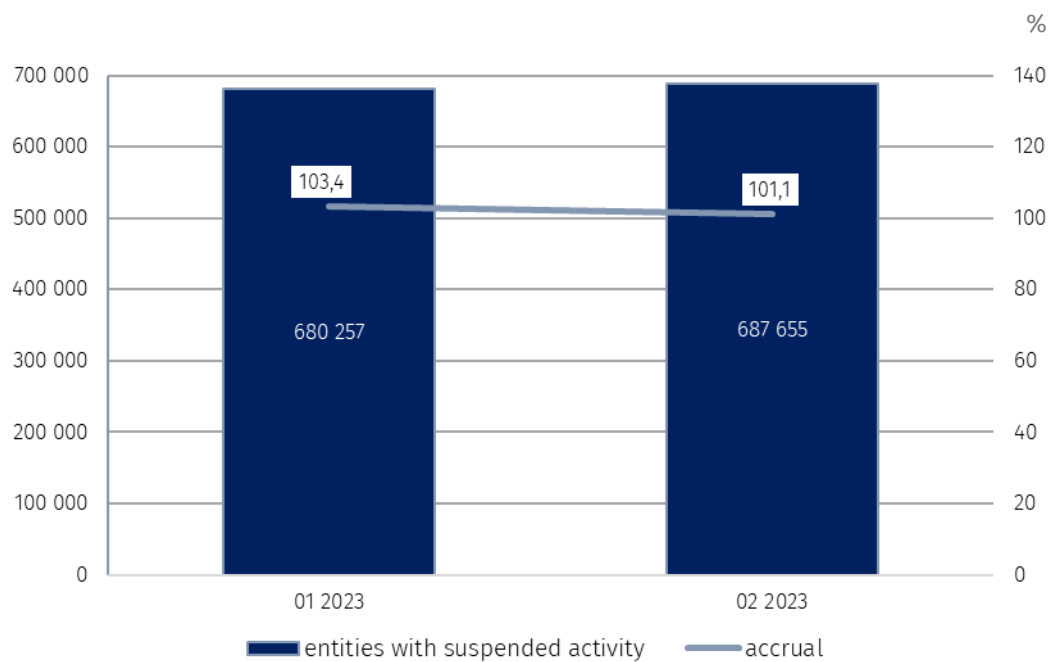
**Chart 1. The number of newly registered entities entered in the REGON register**
